# **Protect Our Students Act of 2018**

- FOR the purpose of requiring a certain educational accountability program to include certain school quality indicators; altering the maximum percentage of a certain total of academic indicators that may comprise a certain composite score; repealing a prohibition that certain indicators be weighted in a certain manner; repealing a requirement that a certain indicator be an academic indicator; making this Act an emergency measure; and generally relating to education accountability plans.

- 19 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, 20 That the Laws of Maryland read as follows:

2 (a) (1) The State Board, the State Superintendent, each county board, and 3 each public school shall implement a program of education accountability for the operation 4 and management of the public schools.

5 (2) A Consolidated State Plan to improve student outcomes submitted by 6 the Department to the United States Department of Education under the federal 7 Elementary and Secondary Education Act shall comply with the requirements of this 8 subtitle.

9 (c) (1) National standardized testing may not be the only measure for 10 evaluating educational accountability.

11 (2) (i) An educational accountability program shall include at least 12 three school quality indicators that measure the comparative opportunities provided to 13 students or the level of student success in public schools.

# 14 (ii) OF THE SCHOOL QUALITY INDICATORS REQUIRED UNDER 15 SUBPARAGRAPH (I) OF THIS PARAGRAPH:

16 1. One [of the school quality indicators under subparagraph
 (i) of this paragraph] shall be school climate surveys THAT INCLUDE AT LEAST ONE
 QUESTION TO EDUCATORS REGARDING THE RECEIPT OF CRITICAL INSTRUCTIONAL
 FEEDBACK; AND

20 **2. O**NE SHALL BE ACCESS TO OR CREDIT FOR 21 COMPLETION OF A WELL-ROUNDED CURRICULUM THAT IS INDICATIVE OF 22 ON-TRACK PROGRESS AT KEY TRANSITION POINTS WITHIN ELEMENTARY AND 23 SECONDARY EDUCATION.

- 24 [2. The school climate surveys shall include at least one 25 question to educators regarding the receipt of critical instructional feedback.]

7 8	(iv) The school quality indicators used in subparagraph (i) of this paragraph may not be based on student testing.
9 10	(v) 1. The State Board shall establish a composite score that provides for meaningful differentiation of schools under the school accountability system.

13	A. Include both academic and school quality indicators;
$\begin{array}{c} 14\\ 15\\ 16\end{array}$	B. Incorporate a methodology that compares schools that share similar demographic characteristics, including the proportion of economically disadvantaged students, as defined by the State in accordance with federal law; and
17 18	C. Be reported in a manner that states for each score the individual indicator score that is used to calculate the composite score for each school.
19 20	3. The combined total of the academic indicators may not exceed [65%] <b>80%</b> of the composite score.
21	4. The composite score:
22	A. Shall be calculated numerically in a percentile form; and
23	B. May not be reported using a letter grade model.
$\begin{array}{c} 24 \\ 25 \end{array}$	5. [No academic indicator may be weighted as less than 10% of the total amount of the composite score.
$26 \\ 27 \\ 28$	6. No school quality indicator described under paragraph (2) of this subsection may be weighted as less than 10% of the total amount of the composite score.
29 30	7.] Subject to this subparagraph, the final weights of the academic and school quality indicators shall be determined by the State Board, with

1 stakeholder input.

2 [(vi) Of the academic indicators established by the State Board under 3 subparagraph (v) of this paragraph, one shall be access to or credit for completion of a 4 well-rounded curriculum that is indicative of on-track progress at key transition points 5 within elementary and secondary education.]

6 SECTION 2. AND BE IT FURTHER ENACTED, That this Act is an emergency 7 measure, is necessary for the immediate preservation of the public health or safety, has 8 been passed by a yea and nay vote supported by three-fifths of all the members elected to 9 each of the two Houses of the General Assembly, and shall take effect from the date it is 10 enacted.
