1 AN ACT concerning

2 **Morgan State University – Board of Regents – Terms of Members**

3 FOR the purpose of providing that certain members of the Board of Regents of Morgan
4 State University whose ~~term is~~ terms are scheduled to expire on a certain date may
5 serve up to a certain number of consecutive terms; making a stylistic change; and
6 generally relating to the terms of members of the Board of Regents of Morgan State
7 University.

8 BY repealing and reenacting, with amendments,
9 Article – Education
10 Section 14–102
11 Annotated Code of Maryland
12 (2014 Replacement Volume and 2017 Supplement)

13 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
14 That the Laws of Maryland read as follows:

15 **Article – Education**

16 14–102.

17 (a) The government of the University is vested in the Board of Regents.

18 (b) The Board of Regents consists of 15 members appointed by the Governor with
19 the advice and consent of the Senate.

1 (c) (1) One member of the Board of Regents shall be a student in good
2 academic standing at the University who:

3 (i) Is at least 18 years old; and

4 (ii) Has the qualifications required to be student body president.

5 (2) The student member serves for a term of 1 year and until a successor is
6 appointed and qualifies.

7 (3) The student may be a resident of a state other than Maryland, but the
8 residency status of the student may not be considered in determining the number of
9 resident or nonresident regents as provided for in subsection (d)(2) of this section.

10 (d) (1) (i) Except for the student member, each member serves for a term
11 of 5 years and until a successor is appointed and qualifies. The terms are staggered as
12 required by the terms of the members serving on December 31, 2012.

13 (ii) 1. **[A] EXCEPT AS PROVIDED IN SUBSUBPARAGRAPH 2**
14 **OF THIS SUBPARAGRAPH, A member may not serve more than two consecutive terms of 5**
15 **years.**

16 2. **A MEMBER WHOSE TERM IS SCHEDULED TO EXPIRE**
17 **ON JUNE 30, 2019, MAY SERVE UP TO THREE CONSECUTIVE TERMS OF 5 YEARS.**

18 (2) Except for the student member, no more than **[3] THREE** members of
19 the Board of Regents who are not alumni of Morgan State University may be residents of
20 other states.

21 (3) A member appointed to fill a vacancy in an unexpired term serves only
22 for the remainder of that term and until a successor is appointed and qualifies.

23 (e) Each member of the Board of Regents:

24 (1) Serves without compensation; and

25 (2) Is entitled to reimbursement for expenses in accordance with the
26 Standard State Travel Regulations.

27 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July
28 1, 2018.
