1 AN ACT concerning

2 **Video Lottery Terminal Revenues – Purse Dedication Account – Standardbred**
3 **Racetrack Operating Loss Assistance**

4 FOR the purpose of providing for certain calendar years the authorization to use certain
5 Purse Dedication Account funds generated from video lottery proceeds for operating
6 loss assistance by the Ocean Downs Race Course and Rosecroft Raceway to support
7 a minimum number of annual live racing days at each race course; and generally
8 relating to the use of Purse Dedication Account funds by the Ocean Downs Race
9 Course and Rosecroft Raceway for operating loss assistance.

20 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
21 That the Laws of Maryland read as follows:

1 **Article – State Government**

2 9–1A–27.

3 (a) Except as provided in subsections (b) and (c) of this section and §
4 9–1A–26(a)(3) of this subtitle, on a properly approved transmittal prepared by the
5 Commission, the Comptroller shall pay the following amounts from the proceeds of video
6 lottery terminals at each video lottery facility:

7 (4) 6% to the Purse Dedication Account established under § 9–1A–28 of this
8 subtitle, not to exceed a total of \$100,000,000 to the Account annually;

9 9–1A–28.

10 (a) There is a Purse Dedication Account under the authority of the State Racing
11 Commission.

12 (e) The amount of funds allocated to standardbred purses and the Standardbred
13 Race Fund shall be allocated as follows:

14 (1) 89% to standardbred purses at Rosecroft Raceway, Ocean Downs Race
15 Course, and the racecourse in Allegany County, allocated based on the number of live racing
16 days at each track location; and

17 (g) (1) Of the amount provided from the Purse Dedication Account under
18 subsection (e)(1) of this section:

19 (i) for Ocean Downs Race Course, up to \$1,200,000 each year for
20 calendar years [2015, 2016, 2017,] 2018, [and] 2019, **2020, 2021, 2022, 2023, AND 2024**
21 may be used to provide financial assistance for operating losses, in accordance with
22 generally accepted accounting principles, to support a minimum of 40 annual live racing
23 days [for calendar years 2015, 2016, 2017, 2018, and 2019] unless the racing licensee is
24 prevented by weather, acts of God, or other circumstances beyond the racing licensee's
25 control; and

26 (ii) for Rosecroft Raceway, up to \$1,200,000 each year for calendar
27 years [2015, 2016, 2017,] 2018, [and] 2019, **2020, 2021, 2022, 2023, AND 2024** may be
28 used to provide financial assistance for operating losses, in accordance with generally
29 accepted accounting principles, to support a minimum of 40 annual live racing days [for
30 calendar years 2015, 2016, 2017, 2018, and 2019] unless the racing licensee is prevented
31 by weather, acts of God, or other circumstances beyond the racing licensee's control.

32 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
33 October 1, 2018.
