A BILL ENTITLED

1 AN ACT concerning

2 **Community Colleges – Facilities Renewal Grant Program – Established**

3 FOR the purpose of establishing the Community College Facilities Renewal Grant
4 Program; requiring the Maryland Higher Education Commission to administer the
5 Program; requiring the Governor to annually appropriate a certain amount in a
6 certain budget to the Commission; requiring a certain appropriation to be in addition
7 to the appropriation for a certain other program; requiring, by a certain date, a
8 community college to provide certain information to the Commission; establishing
9 requirements and limitations in awarding grants; requiring the Commission, in
10 collaboration with the community colleges, to adopt certain regulations; defining
11 certain terms; and generally relating to a facility renewal grant program for
12 community colleges.

18 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
19 That the Laws of Maryland read as follows:

20 **Article – Education**

21 **16–320.**

22 **(A) (1) IN THIS SECTION THE FOLLOWING WORDS HAVE THE MEANINGS**
23 **INDICATED.**

EXPLANATION: CAPITALS INDICATE MATTER ADDED TO EXISTING LAW.

[Brackets] indicate matter deleted from existing law.



1 **(2) "COMMUNITY COLLEGE" INCLUDES BALTIMORE CITY**
2 **COMMUNITY COLLEGE.**

3 **(3) "ELIGIBLE PROJECT" MEANS A FACILITY RENEWAL PROJECT,**
4 **INCLUDING IMPROVEMENTS, REPAIRS, AND DEFERRED MAINTENANCE, THAT HAS A**
5 **TOTAL ESTIMATED COST OF NOT MORE THAN \$1,000,000 AND HAS BEEN SUBMITTED**
6 **TO THE COMMISSION AS PART OF AN ANNUAL MASTER PLAN OR A**
7 **10-YEAR MASTER PLAN.**

8 **(4) "PROGRAM" MEANS THE COMMUNITY COLLEGE FACILITIES**
9 **RENEWAL GRANT PROGRAM.**

10 **(B) (1) THERE IS A COMMUNITY COLLEGE FACILITIES RENEWAL GRANT**
11 **PROGRAM THAT SHALL PROVIDE STATE FUNDS TO COMMUNITY COLLEGES FOR**
12 **IMPROVEMENTS, REPAIRS, AND DEFERRED MAINTENANCE PROJECTS IN**
13 **ACCORDANCE WITH THIS SECTION.**

14 **(2) THE COMMISSION SHALL ADMINISTER THE PROGRAM.**

15 **(C) (1) IN FISCAL YEAR 2019 AND IN EACH FISCAL YEAR THEREAFTER,**
16 **THE GOVERNOR SHALL ANNUALLY APPROPRIATE IN THE OPERATING BUDGET OF**
17 **THE COMMISSION AN AMOUNT EQUAL TO 5% OF THE APPROPRIATION TO THE**
18 **COMMUNITY COLLEGE FACILITIES GRANT PROGRAM IN THE SAME FISCAL YEAR.**

19 **(2) THE APPROPRIATION REQUIRED UNDER PARAGRAPH (1) OF THIS**
20 **SUBSECTION SHALL BE IN ADDITION TO AND MAY NOT SUPPLANT THE AMOUNT**
21 **APPROPRIATED TO THE COMMUNITY COLLEGE FACILITIES GRANT PROGRAM IN**
22 **THE STATE BUDGET.**

23 **(D) (1) ON OR BEFORE SEPTEMBER 1 OF THE FISCAL YEAR PRECEDING**
24 **THE FISCAL YEAR OF THE GRANT AWARD, A COMMUNITY COLLEGE SHALL PROVIDE**
25 **TO THE COMMISSION INFORMATION ABOUT THE ELIGIBLE PROJECT FOR WHICH THE**
26 **COMMUNITY COLLEGE IS REQUESTING A GRANT.**

27 **(2) (I) THE COMMISSION MAY MAKE UP TO EIGHT GRANTS IN EACH**
28 **FISCAL YEAR.**

29 **(II) 1. SUBJECT TO SUBSUBPARAGRAPH 2 OF THIS**
30 **SUBPARAGRAPH, A COMMUNITY COLLEGE MAY NOT RECEIVE A GRANT IN 2**
31 **CONSECUTIVE FISCAL YEARS.**

32 **2. IF A COMMUNITY COLLEGE DOES NOT REQUEST**

1 FUNDS IN A FISCAL YEAR, THE COMMUNITY COLLEGE MAY NOT RECEIVE A GRANT
2 UNTIL THE SECOND FOLLOWING FISCAL YEAR.

3 (III) 1. SUBJECT TO SUBSUBPARAGRAPH 2 OF THIS
4 SUBPARAGRAPH, A COMMUNITY COLLEGE MAY NOT RECEIVE MORE THAN \$500,000
5 IN A FISCAL YEAR UNDER THE PROGRAM.

6 2. IF THE APPROPRIATION PROVIDED UNDER
7 SUBSECTION (C) OF THIS SECTION IS LESS THAN \$4,000,000 IN A FISCAL YEAR, THE
8 APPROPRIATION SHALL BE AWARDED EQUALLY TO EACH COMMUNITY COLLEGE
9 THAT IS ELIGIBLE FOR A GRANT IN THAT FISCAL YEAR.

10 3. SUBJECT TO THE LIMITATION ESTABLISHED IN
11 SUBSUBPARAGRAPH 1 OF THIS SUBPARAGRAPH, A COMMUNITY COLLEGE MAY
12 RECEIVE FUNDING FOR MORE THAN ONE ELIGIBLE PROJECT IN A FISCAL YEAR.

13 (IV) THE COMMISSION SHALL CONSULT WITH EACH COMMUNITY
14 COLLEGE TO DETERMINE WHICH COMMUNITY COLLEGES WILL RECEIVE A GRANT
15 FOR ELIGIBLE PROJECTS UNDER THE PROGRAM IN EACH FISCAL YEAR.

16 (E) THE COMMISSION, IN COLLABORATION WITH THE COMMUNITY
17 COLLEGES, SHALL ADOPT ANY REGULATIONS NECESSARY TO CARRY OUT THE
18 PROVISIONS OF THIS SECTION.

19 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July
20 1, 2018.
