SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
That the Laws of Maryland read as follows:
Article – Education
18–303.
(a) Subject to subsection (d) of this section, each recipient of a Delegate Howard P. Rawlings Educational Excellence Award shall:

- 1 (1) Be accepted for admission in the regular undergraduate program at an eligible institution or be enrolled in a 2-year associate degree program in which the course work is acceptable for transfer credit for an accredited baccalaureate program in an eligible institution;
- 5 (2) [Be] EXCEPT AS PROVIDED IN § 18–303.2 OF THIS SUBTITLE, BE a 6 resident of this State;
- 7 (3) Demonstrate to the Office a definite financial need; and
- 8 (4) Accept any other conditions attached to the award.

- Notwithstanding § 18–303(a)(2) of this subtitle, an individual is Eligible for an award under this subtitle if the individual is eligible for in–State Tuition under this article.

- SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July 1, 2018.
