Public Schools - Student Sunscreen Use - Policy

3 FOR the purpose of requiring each county board of education to adopt a certain written policy to authorize a student to possess and use sunscreen on school property or at a 4 5 school-sponsored activity without written permission from a health care provider; 6 requiring a certain policy to allow certain public school employees to apply or assist 7 a student in applying sunscreen under certain circumstances; providing that a student may only use sunscreen provided by the student's parent or guardian: 8 9 providing that public schools and public school employees that assist a student in 10 the application of sunscreen according to a certain policy cannot be held liable for certain outcomes; requiring each county board to encourage public schools to educate 11 12 students about certain policies and sun safety measures; defining a certain term; and 13 generally relating to a policy for public school student sunscreen use.
