15 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,

3 EACH COMMUNITY COLLEGE SHALL:

4 (1) ENSURE ALL STUDENT ADVISORS ARE TRAINED ON THE UNIQUE  
5 NEEDS AND RESOURCES AVAILABLE FOR STUDENTS WHO ARE VETERANS;

6 (2) EMPLOY AT LEAST ONE ~~FULL-TIME VETERANS ADVISOR TO~~  
7 ~~PROVIDE~~ EMPLOYEE WHO, AS A COMPONENT OF THE EMPLOYEE’S JOB DUTIES AND  
8 RESPONSIBILITIES, PROVIDES COMPREHENSIVE AND INTENSIVE ENROLLMENT AND  
9 ADVISING SERVICES TO CURRENT AND PROSPECTIVE STUDENTS WHO ARE  
10 VETERANS; AND

11 ~~(2)~~ (3) ESTABLISH A VETERANS RESOURCE CENTER ON CAMPUS  
12 TO:

13 (I) PROVIDE ACCESS TO FEDERAL AND STATE VETERANS  
14 RESOURCES;

15 (II) SERVE AS A QUIET PLACE FOR VETERANS TO STUDY;

16 (III) ENABLE VETERANS TO CONNECT TO OTHER VETERANS,  
17 HELPING THEM RENEW THE BONDS OF MILITARY SERVICE; AND

18 (IV) BE THE CENTRAL HUB FOR ALL ACTIVITIES ON CAMPUS  
19 RELATED TO VETERANS.

20 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July  
21 1, 2018.
