BY repealing and reenacting, with amendments, The Public Local Laws of Calvert County Section 5–103 Article 5 – Public Local Laws of Maryland (2002 Edition and August 2017 Supplement) SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That the Laws of Maryland read as follows: **Article 5 – Calvert County** 5-103.The County Commissioners may change an adopted budget [only by resolutions that comply IN ACCORDANCE with this section, the Maryland Constitution,

state laws or public local laws. Changes may not be subdivided to alter the applicability of the requirements of this section.

- (b) The County Commissioners by resolution may establish procedures for the administrative transfer of appropriations between general classifications of expenditures in the current expense budget within the same office or department, transfers between departments, agencies, boards or commissions, interproject transfers of appropriations between capital projects in the capital budget, and the addition, of new budget items.
- 8 (c) Any change involving funds totaling more than \$\frac{\$100,000}{}\$ \$\frac{\$150,000}{}\$ may be 9 made only by resolution approved by the Commissioners after compliance with the 10 publication and hearing requirements applicable to the original proposed budget.
- 11 (d) To meet a public emergency affecting life, health, or property, the 12 Commissioners by resolution may make emergency appropriations from contingent or 13 surplus funds.
- SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect October 1, 2018.
