2 **Howard County – Sheriff’s Salary**

4 FOR the purpose of altering the salary of the Sheriff of Howard County; providing for the
5 application of this Act; and generally relating to the Sheriff of Howard County.

11 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
12 That the Laws of Maryland read as follows:

13 **Article – Courts and Judicial Proceedings**

14 2–309.

15 (o) (1) (i) The Sheriff of Howard County shall receive an annual salary as
16 follows:

17 1. \$85,000 each calendar year for calendar year 2010 through
18 calendar year 2014;

19 2. \$88,000 for calendar year 2015;

20 3. \$91,000 for calendar year 2016;

- 1 4. \$94,000 for calendar year 2017; [and]
2 5. \$97,000 for calendar year 2018;
3 **6. \$101,000 FOR CALENDAR YEAR 2019;**
4 **7. \$105,000 FOR CALENDAR YEAR 2020;**
5 **8. \$109,000 FOR CALENDAR YEAR 2021; AND**
6 **9. \$113,000 FOR CALENDAR YEAR 2022.**

- 7 (ii) 1. The Sheriff shall appoint the number of deputies
8 authorized by the county government.
9 2. The compensation of the deputies shall be set by the
10 county government.

11 SECTION 2. AND BE IT FURTHER ENACTED, That, pursuant to Article III, § 35
12 of the Maryland Constitution, this Act may not be construed to extend or apply to the salary
13 or compensation of the Sheriff of Howard County while serving in a term of office beginning
14 before the effective date of this Act, but the provisions of this Act concerning the salary or
15 compensation of the Sheriff of Howard County shall take effect at the beginning of the next
16 following term of office. This limitation does not apply to an individual appointed or elected
17 after the effective date of this Act to fill out an unexpired term.

18 SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect
19 October 1, 2018.
