## Public Safety - Handgun Permit Review Board - Repeal

- 3 FOR the purpose of altering the process by which a person who is denied a certain handgun 4 permit or renewal of a permit or whose permit is revoked or limited by the Secretary 5 of State Police or the Secretary's designee may appeal the decision; repealing 6 provisions of law relating to the Handgun Permit Review Board; providing that 7 appeals from a certain decision by the Secretary or the Secretary's designee may be 8 made to the Office of Administrative Hearings in a certain manner; providing that a 9 person whose application for a certain permit or renewal of a permit is not acted on 10 by the Secretary within a certain period may request a certain hearing before the Office of Administrative Hearings; making conforming changes; and generally 11 12 relating to handgun permits.

- 30 (2) A person whose application for a permit or renewal of a permit is not acted on by the Secretary within 90 days after submitting the application to the Secretary may request a hearing before the [Board] **OFFICE OF ADMINISTRATIVE HEARINGS** by

1 filing a written request with the [Board] **SECRETARY**.

[(b) Within 90 days after receiving a request to review a decision of the Secretary, the Board shall:

- 4 (1) review the record developed by the Secretary; or
- 5 (2) conduct a hearing.
- 6 (c) The Board may receive and consider additional evidence submitted by a party 7 in conducting a review of the decision of the Secretary.
- 8 (d) (1) Based on the Board's consideration of the record and any additional 9 evidence, the Board shall sustain, reverse, or modify the decision of the Secretary.
- 10 (2) If the action by the Board results in the denial of a permit or renewal of 11 a permit or the revocation or limitation of a permit, the Board shall submit in writing to 12 the applicant or the holder of the permit the reasons for the action taken by the Board.]
- [(e)] (B) (1) Any hearing and any subsequent proceedings of judicial review shall be conducted in accordance with Title 10, Subtitle 2 of the State Government Article.
