CHAPTER

1 AN ACT concerning

2 Admissions and Amusement Tax – Baltimore County – <u>Fees for Nonprofit</u> 3 Amateur Sports League Fees

- FOR the purpose of authorizing the County Executive and County Council of Baltimore 4 5 County to exempt from the admissions and amusement tax certain gross receipts 6 from any charge or fee to participate in an amateur recreational sports event or 7 league administered by a nonprofit entity; prohibiting in Baltimore County the imposition of the admissions and amusement tax for certain gross receipts from a 8 9 charge or fee to participate in an amateur recreational sports event or league that 10 was collected before a certain date; providing that, notwithstanding a certain 11 provision of this Act, Baltimore County is not required to issue a refund for certain admissions and amusement taxes collected before a certain date; and generally 12 13 relating to exemptions from the admissions and amusement tax.

- 11 recreational sports event or league.
- 12 (b) Notwithstanding subsection (a) of this section, Baltimore County is not required to issue a refund of any admissions and amusement taxes imposed on the gross 13 receipts from any charge or fee that is collected before July 1, 2018, for participation in an 14 15 amateur recreational sports event or league.
- 16 SECTION 2. 3. AND BE IT FURTHER ENACTED, That this Act shall take effect 17 July 1, 2018.
