A BILL ENTITLED

1 AN ACT concerning

2 **Higher Education – University System of Maryland – Quasi-Endowment Funds**

3 FOR the purpose of authorizing the Board of Regents of the University System of Maryland
4 to transfer up to a certain amount of funds from the non-State supported fund
5 balance to a quasi-endowment fund; limiting the use of certain proceeds to certain
6 purposes; stating the intent of the General Assembly for the source of a certain
7 transfer; and generally relating to quasi-endowment funds of the University System
8 of Maryland.

14 Preamble

15 WHEREAS, In Chapter 266 of the Acts of 2013, the General Assembly authorized
16 the University System of Maryland to create a quasi-endowment fund to help fund-raising
17 and other related activities at the constituent institutions of the University System of
18 Maryland; and

19 WHEREAS, The General Assembly has encouraged its institutions of higher
20 education to raise supplemental funds from the private sector through innovative
21 fund-raising to support Maryland citizens; and

22 WHEREAS, In 2017 the A. James & Alice B. Clark Foundation made an
23 unprecedented investment of \$219,000,000 to the State's flagship institution, the
24 University of Maryland, College Park Campus, for the purpose of, among other initiatives,

1 increasing college access and affordability through need-based scholarships; and

2 WHEREAS, This private donation was one of the largest ever given to a public
3 university in the nation's history; and

4 WHEREAS, The Clark Challenge for Maryland Promise offers the opportunity to
5 create a scholarship fund of at least \$100,000,000 with supplemental matching funds to
6 support Maryland students at the University of Maryland, College Park Campus and
7 students transferring from community college with financial need-based scholarships;
8 now, therefore,

9 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
10 That the Laws of Maryland read as follows:

11 **Article – Education**

12 12–104.

13 (e) (2) (i) Subject to subparagraphs (ii) [and], (iii), AND (IV) of this
14 paragraph, the Board may maintain and manage quasi-endowment funds.

15 (ii) The Board may only make a one-time transfer of no more than
16 \$50,000,000 from the non-State supported fund balance held and invested by the State
17 Treasurer to the quasi-endowment fund.

18 (iii) 1. Subject to the limitation under subparagraph 2 of this
19 subparagraph, the Board may make only a one-time transfer of no more than \$50,000,000
20 from the State-supported fund balance held and invested by the State Treasurer to the
21 quasi-endowment fund.

22 2. The Board may use the investment proceeds for facility
23 renewal projects relating only to capital facilities used for State-supported activities.

24 (IV) 1. SUBJECT TO THE LIMITATION UNDER
25 SUBSUBPARAGRAPH 2 OF THIS SUBPARAGRAPH, THE BOARD MAY MAKE ONLY A
26 ONE-TIME TRANSFER OF NO MORE THAN \$25,000,000 FROM THE NON-STATE
27 SUPPORTED FUND BALANCE HELD AND INVESTED BY THE STATE TREASURER TO
28 THE QUASI-ENDOWMENT FUND.

29 2. THE BOARD MAY USE THE INVESTMENT PROCEEDS
30 ONLY TO MATCH A PRIVATELY FUNDED SCHOLARSHIP PROGRAM AT THE
31 UNIVERSITY OF MARYLAND, COLLEGE PARK CAMPUS.

32 SECTION 2. AND BE IT FURTHER ENACTED, That it is the intent of the General
33 Assembly that, in transferring the funds authorized to be transferred under this Act, the
34 Board of Regents of the University System of Maryland make a transfer from the fund

1 balance held on account of and attributable to the University of Maryland, College Park
2 Campus.

3 SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect July
4 1, 2018.
