A BILL ENTITLED

1 AN ACT concerning

2 **Motor Vehicles – Aggressive Driving**

3 FOR the purpose of altering the motor vehicle offense of aggressive driving to include the
4 commission of a certain number of an alternate set of certain motor vehicle offenses
5 under certain circumstances; establishing that certain persons charged with a
6 violation for aggressive driving must appear in court and may not prepay the fine;
7 and generally relating to aggressive driving.

18 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
19 That the Laws of Maryland read as follows:

20 **Article – Transportation**

22 (a) After the conviction of an individual for a violation of Title 2, Subtitle 5,
23 § 2–209, § 3–211, or § 10–110 of the Criminal Law Article, or of the vehicle laws or

1 regulations of this State or of any local authority, points shall be assessed against the
2 individual as of the date of violation and as follows:

3 (25) Aggressive driving in violation of § 21-901.2 of this
4 article.....5 points

6 (A) A person is guilty of aggressive driving if [the person commits three or more
7 of the following offenses], at the same time or during a single and continuous period of
8 driving [in violation of], **THE PERSON VIOLATES:**

9 (1) **THREE OR MORE OF THE FOLLOWING PROVISIONS:**

10 [(1)] (I) § 21-202 of this title (Traffic lights with steady indication);

11 [(2)] (II) § 21-303 of this title (Overtaking and passing vehicles);

12 [(3)] (III) § 21-304 of this title (Passing on right);

13 [(4)] (IV) § 21-309 of this title (Driving on laned roadways);

14 [(5)] (V) § 21-310 of this title (Following too closely);

15 [(6)] (VI) § 21-403 of this title (Failure to yield right-of-way); or

16 [(7)] (VII) § 21-801.1 of this title (Exceeding a maximum speed limit or
17 posted maximum speed limit); **OR**

18 (2) **TWO OR MORE OF THE FOLLOWING PROVISIONS:**

19 (I) § 21-202 OF THIS TITLE (**TRAFFIC LIGHTS WITH STEADY**
20 **INDICATION**);

21 (II) § 21-304(C) OF THIS TITLE (**DRIVING OFF ROADWAY TO**
22 **PASS ON RIGHT**);

23 (III) § 21-310 OF THIS TITLE (**FOLLOWING TOO CLOSELY**);

24 (IV) § 21-403 OF THIS TITLE (**FAILURE TO YIELD**
25 **RIGHT-OF-WAY**); **OR**

26 (V) § 21-801.1 OF THIS TITLE **FOR EXCEEDING A MAXIMUM**
27 **SPEED LIMIT OR POSTED MAXIMUM SPEED LIMIT BY 20 MILES AN HOUR OR MORE.**

1 **(B) A PERSON WHO IS CHARGED WITH A VIOLATION OF SUBSECTION (A)(2)**
2 **OF THIS SECTION:**

3 **(1) MUST APPEAR IN COURT; AND**

4 **(2) MAY NOT PREPAY THE FINE.**

6 (a) A holder of a provisional driver's license who is under the age of 18 years is
7 guilty of high-risk driving if the holder of the provisional license commits any of the
8 following violations:

9 (1) § 21-901.1 of this subtitle (Reckless and negligent driving);

10 (2) § 21-901.2 of this subtitle (Aggressive driving); or

11 (3) § 21-1116 of this title (Race or speed contest prohibited).

12 (b) (1) If the individual is convicted of a violation specified in subsection (a) of
13 this section, the Administration shall suspend the individual's driver's license:

14 (i) For a first offense, for 6 months; and

15 (ii) For a second or subsequent offense, for 1 year.

16 (2) An individual subject to a license suspension under this subsection may
17 request a hearing as provided for a suspension or revocation under Title 12, Subtitle 2 of
18 this article.

19 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
20 October 1, 2018.
