## A BILL ENTITLED

1 AN ACT concerning

2 **Hate Crimes – Civil Remedy**

3 FOR the purpose of providing that a person who is aggrieved by an act that would constitute  
4 a violation of certain hate crime laws may bring a civil action against a certain  
5 person; authorizing the court to impose an injunction and award certain damages;  
6 providing for the application of this Act; and generally relating to the right to file a  
7 civil action for a hate crime.

13 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,  
14 That the Laws of Maryland read as follows:

15 **Article – Criminal Law**

16 **10–309.**

17 **(A) A PERSON WHO IS AGGRIEVED BY AN ACT THAT WOULD CONSTITUTE A**  
18 **VIOLATION OF THIS SUBTITLE MAY BRING A CIVIL ACTION AGAINST THE PERSON OR**  
19 **PERSONS WHO COMMITTED THE ACT IN A COURT OF COMPETENT JURISDICTION.**

20 **(B) THE COURT MAY:**

21 **(1) ISSUE AN INJUNCTION TO PREVENT OR RESTRAIN AN ACT THAT**  
22 **WOULD CONSTITUTE A VIOLATION OF THIS SUBTITLE; AND**

2 **SECTION.**

3           **(C) (1) DAMAGES AWARDED BY A COURT UNDER THIS SECTION MAY**  
4 **INCLUDE:**

5                   **(I) ECONOMIC DAMAGES AND ANY OTHER PECUNIARY LOSS**  
6 **SUSTAINED BY THE PLAINTIFF THAT WAS PROXIMATELY CAUSED BY THE VIOLATION**  
7 **OF THIS SUBTITLE;**

8                   **(II) NONECONOMIC DAMAGES, INCLUDING:**

9                           **1. PAIN AND SUFFERING;**

10                           **2. EMOTIONAL DISTRESS;**

11                           **3. MENTAL ANGUISH;**

12                           **4. LOSS OF ENJOYMENT;**

13                           **5. LOSS OF COMPANIONSHIP, SERVICES, AND**

14 **CONSORTIUM; AND**

15                           **6. OTHER NONPECUNIARY LOSS SUSTAINED BY THE**

16 **PLAINTIFF THAT WAS PROXIMATELY CAUSED BY THE ACT THAT WOULD CONSTITUTE**  
17 **A VIOLATION OF THIS SUBTITLE; AND**

18                   **(III) PUNITIVE DAMAGES.**

19                   **(2) THE COURT MAY ALSO AWARD REASONABLE ATTORNEY'S FEES TO**  
20 **A PREVAILING PLAINTIFF.**

21           **(D) DAMAGES AWARDED BY A COURT UNDER SUBSECTION (C)(1)(I) AND (II)**  
22 **OF THIS SECTION SHALL BE EQUAL TO THREE TIMES THE AMOUNT OF ACTUAL**  
23 **DAMAGES.**

24           **(E) THIS SECTION DOES NOT AFFECT ANY LEGAL OR EQUITABLE RIGHT OR**  
25 **REMEDY OTHERWISE PROVIDED BY LAW.**

26           SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall be construed to  
27 apply only prospectively and may not be applied or interpreted to have any effect on or  
28 application to any cause of action arising before the effective date of this Act.

29           SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect

1 October 1, 2018.
