## A BILL ENTITLED

1 AN ACT concerning

2 **Washington County Board of Education – Teachers and Other Personnel –**  
3 **Conclusion of Negotiations**

4 FOR the purpose of requiring certain parties in certain collective bargaining negotiations  
5 in Washington County to make reasonable efforts to conclude negotiations in a  
6 timely manner; and generally relating to negotiations and collective bargaining for  
7 teachers and other personnel of the Washington County Board of Education.

18 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,  
19 That the Laws of Maryland read as follows:

22 (b) (1) Each county board shall submit an annual school budget in writing to
