3 (3) (i) A procurement by a University shall comply with the policies and 4 procedures developed by the University and approved by the Board of Public Works and 5 the Administrative, Executive, and Legislative Review Committee of the General Assembly 6 in accordance with § 12–112 of the Education Article for the University System of 7 Maryland, § 14–109 of the Education Article for Morgan State University, or § 14–405(f) of 8 the Education Article for St. Mary's College of Maryland.

9 (ii) 1. The review and approval of the Board of Public Works 10 shall be required for the following types of contracts with a value that exceeds \$1,000,000:

11 A. capital improvements; AND

12 B. services[; and

C. dispositions of personal property subject to § 10–305 of this article, except for dispositions of personal property that was purchased with the proceeds of a general obligation loan].

16 2. In its review of a contract for services or capital 17 improvements with a value that exceeds \$1,000,000, the Board of Public Works may request 18 the comments of the appropriate agencies, including the Department of Budget and 19 Management and the Department of General Services.

20 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect 21 October 1, 2018.
