2 Election Law – Postelection Tabulation Audit

FOR the purpose of requiring the State Board of Elections to conduct an audit of the accuracy of the voting system's tabulation of votes by completing a certain audit of electronic ballot images and a certain manual audit after each statewide general election; requiring the State Board to complete a certain audit of electronic ballot images after each statewide primary election; authorizing the State Board to complete a certain manual audit after each statewide primary election; requiring the State Board to complete a manual audit of certain precincts and certain early, absentee, and provisional votes following each statewide general election; requiring a manual audit to be completed within a certain period of time; authorizing the State Board to take certain actions if a manual audit shows a discrepancy; requiring the State Board to post a certain report on its website within a certain period of time after the conclusion of a manual audit; requiring the State Board to allow for public observation of a manual audit to the extent practicable; prohibiting an audit under

1 required to complete the audit required under this Act following the 2018 general election. 2 The report shall include the amount of time needed to complete the audit, the number of 3 personnel required to complete the audit, any other costs incurred by the State Board or 4 the local boards of elections to complete the audit, and any other administrative obstacles to completing the audit. 5 6 SECTION 3.
