A BILL ENTITLED

1 AN ACT concerning

2 **One Maryland Economic Development Tax Credits – Simplification and**
3 **Alteration**

4 FOR the purpose of altering the definition of “qualified distressed county” by altering
5 certain income levels in the definition and renaming it to be “Tier I county”; repealing
6 a certain start–up tax credit under the One Maryland Economic Development Tax
7 Credit Program; expanding the eligibility requirements for a certain project tax
8 credit by altering, under certain circumstances, the number of qualified positions
9 that a qualified business entity is required to create; altering the calculation of the
10 project tax credit; requiring the Department of Commerce to certify the amount of
11 the project tax credit; requiring a qualified business entity to report certain
12 information to the Department for certain taxable years; providing that a failure to
13 report the information shall disqualify the qualified business entity from claiming
14 certain credits; repealing a certain limitation on the amount of the project tax credit
15 allowed under certain circumstances; altering the circumstances under which a
16 certain qualified business entity may claim the project tax credit; altering the
17 circumstances under which a qualified business entity may carry forward and claim
18 a refund of certain excess credits; prohibiting a qualified business entity from
19 claiming a certain other credit under certain circumstances; exempting certain
20 property of a qualified business entity from a certain limitation on the applicability
21 of certain Maryland income tax modifications for certain deductions for the cost of
22 business property placed in service that is treated as an expense for federal income
23 tax purposes; exempting certain property of a qualified business entity from a certain
24 limitation on the applicability of certain Maryland income tax modifications for a
25 certain additional depreciation allowance under the federal income tax; requiring
26 the publisher of the Annotated Code of Maryland, in consultation with and subject
27 to the approval of the Department of Legislative Services, to correct any
28 cross–references or terminology rendered incorrect by this Act and to describe any
29 corrections made in an editor’s note following the section affected; altering certain
30 definitions; defining a certain term; making conforming changes; providing for the

23 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
24 That the Laws of Maryland read as follows:

25 **Article – Economic Development**

26 1–101.

27 (a) In this division the following words have the meanings indicated.

28 (b) “County” means a county of the State or Baltimore City.

29 (c) “Department” means the Department of Commerce.

30 (d) “Person” means an individual, receiver, trustee, guardian, personal
31 representative, fiduciary, representative of any kind, partnership, firm, association,
32 corporation, or other entity.

33 [(e) (1) “Qualified distressed county” means a county with:

34 (i) an average rate of unemployment for the most recent 24–month

1 period for which data are available that exceeds 150% of the average rate of unemployment
2 for the State during that period;

3 (ii) an average rate of unemployment for the most recent 24-month
4 period for which data are available that exceeds the average rate of unemployment in the
5 State by at least 2 percentage points; or

6 (iii) an average per capita personal income for the most recent
7 24-month period for which data are available that is equal to or less than 67% of the
8 average per capita personal income for the State during that period.

9 (2) “Qualified distressed county” includes a county that:

10 (i) no longer meets either criterion stated in paragraph (1) of this
11 subsection; but

12 (ii) has met at least one of the criteria at some time during the
13 preceding 24-month period.]

14 **[(f)] (E)** “Secretary” means the Secretary of Commerce.

15 **[(g)] (F)** (1) Except as provided in paragraph (2) of this subsection, “state”
16 means:

17 (i) a state, possession, territory, or commonwealth of the United
18 States; or

19 (ii) the District of Columbia.

20 (2) When capitalized, “State” means Maryland.

21 **(G) (1) “TIER I COUNTY” MEANS A COUNTY WITH:**

22 **(I) AN AVERAGE RATE OF UNEMPLOYMENT FOR THE MOST**
23 **RECENT 24-MONTH PERIOD FOR WHICH DATA ARE AVAILABLE THAT EXCEEDS 150%**
24 **OF THE AVERAGE RATE OF UNEMPLOYMENT FOR THE STATE DURING THAT PERIOD;**

25 **(II) AN AVERAGE RATE OF UNEMPLOYMENT FOR THE MOST**
26 **RECENT 24-MONTH PERIOD FOR WHICH DATA ARE AVAILABLE THAT EXCEEDS THE**
27 **AVERAGE RATE OF UNEMPLOYMENT IN THE STATE BY AT LEAST 2 PERCENTAGE**
28 **POINTS; OR**

29 **(III) A MEDIAN HOUSEHOLD INCOME FOR THE MOST RECENT**
30 **24-MONTH PERIOD FOR WHICH DATA ARE AVAILABLE THAT IS EQUAL TO OR LESS**

1 THAN 75% OF THE MEDIAN HOUSEHOLD INCOME FOR THE STATE DURING THAT
2 PERIOD.

3 (2) "TIER I COUNTY" INCLUDES A COUNTY THAT:

4 (I) NO LONGER MEETS EITHER CRITERION STATED IN
5 PARAGRAPH (1) OF THIS SUBSECTION; BUT

6 (II) HAS MET AT LEAST ONE OF THE CRITERIA AT SOME TIME
7 DURING THE PRECEDING 24-MONTH PERIOD.

8 6-401.

9 (a) In this subtitle the following words have the meanings indicated.

10 (B) "CREDIT YEAR" MEANS THE TAXABLE YEAR IN WHICH A QUALIFIED
11 BUSINESS ENTITY CLAIMS THE TAX CREDIT AUTHORIZED UNDER THIS SUBTITLE.

12 [(b)] (C) "Eligible economic development project" means an economic
13 development project that:

14 (1) establishes or expands a business facility within a [qualified distressed]
15 TIER I county; and

16 (2) is approved for a project tax credit [or a start-up tax credit] in
17 accordance with this subtitle.

18 [(c)] (D) (1) "Eligible project cost" means the cost and expense a qualified
19 business entity incurs to acquire, construct, rehabilitate, install, or equip an eligible
20 economic development project.

21 (2) "Eligible project cost" includes:

22 (i) the cost of:

23 1. obligations for labor and payments made to contractors,
24 subcontractors, builders, and suppliers;

25 2. acquiring land, rights in land, and costs incidental to
26 acquiring land or rights in land;

27 3. contract bonds and insurance needed during the
28 acquisition, construction, or installation of the project;

29 4. test borings, surveys, estimates, plans, specifications,
30 preliminary investigations, environmental mitigation, supervision of construction, and

1 other architectural and engineering services;

2 5. performing duties required by or consequent to the
3 acquisition, construction, and installation of the project;

4 6. installing water, sewer, sewer treatment, gas, electricity,
5 communications, railroads, and similar utilities; and

6 7. bond insurance, letters of credit, or other forms of credit
7 enhancement or liquidity facilities;

8 (ii) the interest cost before and during the acquisition, construction,
9 installation, and equipping of the project, and for up to 2 years after project completion;
10 [and]

11 (iii) legal, accounting, financial, printing, recording, filing, and other
12 fees and expenses incurred to finance the project[.]; AND

13 [(d) (1) (IV) ["Eligible start-up cost" means] a qualified business entity's cost
14 to furnish and equip a new location for ordinary business functions[.], INCLUDING:

15 [(2) "Eligible start-up cost" includes:]

16 [(i) 1. the cost of computers, nonrecurring costs of fixed
17 telecommunications equipment, furnishings, and office equipment; and

18 [(ii) 2. expenditures for moving costs, separation costs, and other
19 costs directly related to moving from outside of the State to a location in a [qualified
20 distressed] TIER I county.

21 (e) "Project tax credit" means a tax credit for eligible project costs allowed under
22 § 6-403 of this subtitle.

23 (f) "Qualified business entity" means a person that:

24 (1) (i) conducts or operates a trade or business in the State; or

25 (ii) operates in the State and is exempt from taxation under §
26 501(c)(3) or (4) of the Internal Revenue Code; and

27 (2) is certified in accordance with [§ 6-402 of] this subtitle as qualifying
28 for a project tax credit [or a start-up tax credit] under this subtitle.

29 (g) (1) "Qualified position" means a position that:

30 (i) is a full-time position and is of indefinite duration;

1 (ii) pays at least [150%] **120%** of the [federal] **STATE** minimum
2 wage;

3 (iii) is in a [qualified distressed] **TIER I** county;

4 (iv) is newly created because a business facility begins or expands in
5 one location in a [qualified distressed] **TIER I** county; and

6 (v) is filled.

7 (2) “Qualified position” does not include a position that is:

8 (i) created when an employment function is shifted from an existing
9 business facility of a business entity in the State to another business facility of the same
10 business entity if the position is not a net new job in the State;

11 (ii) created through a change in ownership of a trade or business;

12 (iii) created through a consolidation, merger, or restructuring of a
13 business entity if the position is not a net new job in the State;

14 (iv) created when an employment function is contractually shifted
15 from an existing business entity in the State to another business entity if the position is
16 not a net new job in the State; or

17 (v) filled for a period of less than 12 months.

18 [(h) “Start-up tax credit” means a tax credit for eligible start-up costs allowed
19 under § 6-404 of this subtitle.]

20 6-402.

21 (a) (1) To qualify for a project tax credit [or a start-up tax credit], a person
22 shall be certified by the Secretary as meeting the requirements of this subtitle and as being
23 eligible for the tax credit.

24 (2) The Secretary may not certify a person as a qualified business entity
25 unless the person notifies the Department of its intent to seek certification before hiring
26 any qualified employees to fill the qualified positions necessary to satisfy the employment
27 threshold under subsection (b)(2) of this section.

28 (b) To be eligible for a project tax credit [or a start-up tax credit], a person shall:

29 (1) establish or expand a business facility that:

1 (i) is located in a [qualified distressed] **TIER I** county; and

2 (ii) 1. is located in a priority funding area under § 5–7B–02 of
3 the State Finance and Procurement Article; or

4 2. is eligible for funding outside of a priority funding area
5 under § 5–7B–05 or § 5–7B–06 of the State Finance and Procurement Article;

6 (2) during any 24–month period, create at least [25] **THE NUMBER OF**
7 qualified positions at the new or expanded business facility **SPECIFIED IN § 6–403(B) OF**
8 **THIS SUBTITLE**; and

9 (3) be primarily engaged at the new or expanded business facility in any
10 combination of:

11 (i) manufacturing or mining;

12 (ii) transportation or communications;

13 (iii) filmmaking, resort business, or recreational business;

14 (iv) agriculture, forestry, or fishing;

15 (v) research, development, or testing;

16 (vi) biotechnology;

17 (vii) computer programming, information technology, or other
18 computer–related services;

19 (viii) central services for a business entity engaged in financial
20 services, real estate services, or insurance services;

21 (ix) the operation of central administrative offices;

22 (x) the operation of a company headquarters other than the
23 headquarters of a professional sports organization;

24 (xi) the operation of a public utility;

25 (xii) warehousing; or

26 (xiii) other business services.

27 (c) To be certified as a qualified business entity for a project tax credit [or a
28 start–up tax credit], a person shall submit to the Secretary an application that specifies:

- 1 (1) the effective date of the start-up or expansion;
- 2 (2) the number of full-time employees before the start-up or expansion and
3 the payroll of the existing employees;
- 4 (3) the number of qualified positions created and qualified employees hired
5 and the payroll of the new qualified employees; and
- 6 (4) any other information that the Secretary requires by regulation.
- 7 (d) The Secretary may require any information required under this section to be
8 verified by an independent auditor that the qualified business entity selects.

9 6-403.

10 (a) (1) A qualified business entity may claim a project tax credit for the cost of
11 an eligible economic development project in a [qualified distressed] **TIER I** county if the
12 total eligible project cost for the eligible economic development project is at least \$500,000.

13 (2) A qualified business entity is not entitled to a project tax credit for a
14 cost incurred before notifying the Department of its intent to seek certification as qualifying
15 for the project tax credit.

16 (b) (1) **(I)** Subject to the limitation in paragraph (2) of this subsection, the
17 project tax credit allowed under this section is the lesser of **[\$5,000,000] THE MAXIMUM**
18 **AMOUNT SPECIFIED IN SUBPARAGRAPH (II) OF THIS PARAGRAPH** and the total eligible
19 project cost for the eligible economic development project, less the amount of the credit
20 previously taken for the project in prior taxable years.

21 **(II) FOR PURPOSES OF CALCULATION OF THE CREDIT UNDER**
22 **SUBPARAGRAPH (I) OF THIS PARAGRAPH, THE MAXIMUM AMOUNT IS:**

23 **1. \$5,000,000, IF THE QUALIFIED BUSINESS ENTITY**
24 **CREATES AT LEAST 50 QUALIFIED POSITIONS;**

25 **2. \$2,500,000, IF THE QUALIFIED BUSINESS ENTITY**
26 **CREATES AT LEAST 25 QUALIFIED POSITIONS BUT FEWER THAN 50 QUALIFIED**
27 **POSITIONS; OR**

28 **3. \$1,000,000, IF THE QUALIFIED BUSINESS ENTITY**
29 **CREATES AT LEAST 10 QUALIFIED POSITIONS BUT FEWER THAN 25 QUALIFIED**
30 **POSITIONS.**

31 (2) Except as provided in subsections [(e)] **(D)** and [(f)] **(E)** of this section,

1 the project tax credit allowed in a taxable year may not exceed the State tax for that year
2 on the qualified business entity's income [generated by or arising out of the eligible
3 economic development project, as determined under subsections (c) and (d) of this section].

4 **(3) THE DEPARTMENT SHALL CERTIFY THE AMOUNT OF THE**
5 **PROJECT TAX CREDIT FOR WHICH A QUALIFIED BUSINESS ENTITY IS ELIGIBLE.**

6 **(4) (I) A QUALIFIED BUSINESS ENTITY SHALL REPORT TO THE**
7 **DEPARTMENT THE AMOUNT OF THE PROJECT TAX CREDIT THAT THE ENTITY CLAIMS**
8 **ON THE ENTITY'S TAX RETURN FOR EACH TAXABLE YEAR THAT THE ENTITY CLAIMS**
9 **ANY PORTION OF THE PROJECT TAX CREDIT.**

10 **(II) THE FAILURE OF THE QUALIFIED BUSINESS ENTITY TO**
11 **PROVIDE THE INFORMATION REQUIRED UNDER SUBPARAGRAPH (I) OF THIS**
12 **PARAGRAPH SHALL DISQUALIFY THE ENTITY FROM CLAIMING ANY UNCLAIMED**
13 **AMOUNT OF THE PROJECT TAX CREDIT.**

14 **[(c) (1) This subsection does not apply to a person subject to taxation under**
15 **Title 6 of the Insurance Article.**

16 (2) The State tax for the taxable year on a qualified business entity's
17 income generated by or arising out of an eligible economic development project equals the
18 difference between:

19 (i) the State tax without regard to this subtitle; and

20 (ii) the State tax on the qualified business entity's Maryland taxable
21 income reduced by the amount of its net income attributable to the eligible economic
22 development project.

23 (3) If an eligible economic development project is a totally separate facility,
24 net income attributable to the project shall be determined under the separate accounting
25 method reflecting only the gross income, deductions, expenses, gains, and losses that are
26 directly attributable to the facility and the overhead expenses apportioned to the facility.

27 (4) If the eligible economic development project is an expansion to a
28 previously existing facility:

29 (i) net income attributable to the entire facility shall be determined
30 under the separate accounting method reflecting only the gross income, deductions,
31 expenses, gains, and losses that are directly attributable to the facility and the overhead
32 expenses apportioned to the facility; and

33 (ii) net income attributable to the eligible economic development
34 project shall be determined by apportioning the net income of the entire facility, as
35 calculated under item (i) of this paragraph, to the eligible economic development project by

1 a formula approved by the Comptroller or the State Department of Assessments and
2 Taxation.

3 (5) If the Comptroller or the State Department of Assessments and
4 Taxation is satisfied that the nature and activities of a qualified business entity make it
5 impractical to use the separate accounting method, the qualified business entity shall
6 determine net income from the eligible economic development project using an alternative
7 method approved by the Comptroller or the State Department of Assessments and
8 Taxation.]

9 [(d)] (C) A qualified business entity that is subject to taxation under Title 6 of
10 the Insurance Article may [not] claim the project tax credit [for the taxable year in which
11 the project is placed in service or for the next 4 taxable years] **AGAINST THE INSURANCE
12 PREMIUM TAX.**

13 [(e)] (D) (1) Subject to paragraph (2) of this subsection, if the eligible project
14 cost for the eligible economic development project exceeds the State tax on the qualified
15 business entity's income [generated by or arising out of the project for the taxable year in
16 which the project is placed in service], the qualified business entity may apply any excess
17 as a project tax credit for succeeding taxable years against the State tax on the qualified
18 business entity's income [generated by or arising out of the project] until the earlier of:

19 (i) the full amount of the excess is used; or

20 (ii) the expiration of the [14th] **10TH** taxable year following the
21 [taxable year in which the project is placed in service] **CREDIT YEAR.**

22 (2) (i) A qualified business entity may claim a prorated share of the
23 credit under this subsection if:

24 1. during any taxable year after the qualified business entity
25 is certified for the tax credit, the number of qualified positions filled by the qualified
26 business entity falls below [25] **THE MINIMUM NUMBER OF QUALIFIED POSITIONS
27 REQUIRED TO QUALIFY FOR THE PROJECT TAX CREDIT**, but does not fall below 10; and

28 2. the qualified business entity has maintained at least [25]
29 **THE MINIMUM NUMBER OF** qualified positions **REQUIRED TO QUALIFY FOR THE
30 PROJECT TAX CREDIT** for at least 5 years.

31 (ii) The prorated share of the credit is calculated based on the
32 number of qualified positions filled for the taxable year divided by [25] **THE MINIMUM
33 NUMBER OF QUALIFIED POSITIONS REQUIRED TO QUALIFY FOR THE PROJECT TAX
34 CREDIT.**

35 [(f)] (E) (1) Subject to the limitation in paragraph (4) of this subsection [and

1 subject to § 6–405 of this subtitle], this subsection applies to any taxable year after the 4th
2 [but before the 15th taxable year following the taxable year in which the project is placed
3 in service] **CREDIT YEAR**.

4 (2) A qualified business entity other than a person subject to taxation
5 under Title 6 of the Insurance Article may[:

6 (i) apply any excess of eligible project costs for the eligible economic
7 development project over the cumulative amount used as a project tax credit for the taxable
8 year and all prior taxable years as a tax credit against the State tax for the taxable year on
9 the qualified business entity's income other than income generated by or arising out of the
10 project; and

11 (ii) claim a refund in the amount, if any, by which the **QUALIFIED**
12 **BUSINESS ENTITY'S** unused excess exceeds the State tax for the taxable year [on the
13 qualified business entity's income other than income generated by or arising out of the
14 project].

15 (3) A qualified business entity that is subject to taxation under Title 6 of
16 the Insurance Article may:

17 (i) apply any excess of eligible project costs for the eligible economic
18 development project over the cumulative amount used as a project tax credit for the taxable
19 year and all prior taxable years as a tax credit against the premium tax imposed for the
20 taxable year; and

21 (ii) claim a refund in the amount, if any, by which the unused excess
22 exceeds the premium tax for the taxable year.

23 (4) For any taxable year, the total amount [used as a project tax credit and]
24 claimed as a refund under this subsection may not exceed the amount of tax that the
25 qualified business entity is required to withhold for the taxable year from the wages of
26 qualified employees under § 10–908 of the Tax – General Article.

27 (5) (i) A qualified business entity may claim a prorated share of the
28 credit under this subsection if:

29 1. during any taxable year after the qualified business entity
30 is certified for the tax credit, the number of qualified positions filled by the qualified
31 business entity falls below [25] **THE MINIMUM NUMBER OF QUALIFIED POSITIONS**
32 **REQUIRED TO QUALIFY FOR THE PROJECT TAX CREDIT**, but does not fall below 10; and

33 2. the qualified business entity has maintained at least [25]
34 **THE MINIMUM NUMBER OF** qualified positions **REQUIRED TO QUALIFY FOR THE**
35 **PROJECT TAX CREDIT** for at least 5 years.

1 (ii) The prorated share of the credit is calculated based on the
2 number of qualified positions filled for the taxable year divided by [25] THE MINIMUM
3 NUMBER OF QUALIFIED POSITIONS REQUIRED TO QUALIFY FOR THE PROJECT TAX
4 CREDIT.

5 [(g)] (F) A qualified business entity shall attach the certification required under
6 § 6-402 of this subtitle to the tax return on which the project tax credit is claimed.

7 [6-404.

8 (a) (1) A qualified business entity that locates in a qualified distressed county
9 may claim a start-up tax credit in the amount provided in subsection (b) of this section.

10 (2) A qualified business entity is not entitled to a start-up tax credit for a
11 cost incurred before notifying the Department of its intent to seek certification as qualifying
12 for the start-up tax credit.

13 (b) The start-up tax credit allowed under this section for each taxable year equals
14 the least of:

15 (1) the qualified business entity's total eligible start-up cost associated
16 with establishing or expanding a business facility in the qualified distressed county, less
17 the amount of the credit previously taken for the project;

18 (2) the product of multiplying \$10,000 times the number of qualified
19 employees employed at the new or expanded business facility; or

20 (3) \$500,000.

21 (c) (1) Subject to paragraph (2) of this subsection, if the start-up tax credit
22 allowed under subsection (b) of this section for the taxable year in which a qualified
23 business entity locates in a qualified distressed county exceeds the total tax otherwise due
24 from the qualified business entity for that taxable year, the qualified business entity may
25 apply the excess as a credit for succeeding taxable years until the earlier of:

26 (i) the full amount of the excess is used; or

27 (ii) the expiration of the 14th taxable year following the taxable year
28 in which the qualified business entity locates in a qualified distressed county.

29 (2) (i) A qualified business entity may claim a prorated share of the
30 credit under this subsection if:

31 1. during any taxable year after the qualified business entity
32 is certified for the tax credit, the number of qualified positions filled by the qualified
33 business entity falls below 25, but does not fall below 10; and

1 2. the qualified business entity has maintained at least 25
2 qualified positions for at least 5 years.

3 (ii) The prorated share of the credit is calculated based on the
4 number of qualified positions filled for the taxable year divided by 25.

5 (d) (1) Subject to the limitation in paragraph (3) of this subsection and subject
6 to § 6-405 of this subtitle, this subsection applies to any taxable year after the 4th but
7 before the 15th taxable year following the taxable year in which the qualified business
8 entity locates in a qualified distressed county.

9 (2) A qualified business entity may claim a refund in the amount, if any,
10 by which the qualified business entity's eligible start-up cost exceeds the cumulative
11 amount used as a start-up tax credit for the taxable year and all prior taxable years.

12 (3) For any taxable year, the total amount claimed as a refund under this
13 subsection may not exceed the amount of tax that the qualified business entity is required
14 to withhold for the taxable year from the wages of qualified employees under § 10-908 of
15 the Tax – General Article.

16 (4) (i) A qualified business entity may claim a prorated share of the
17 credit under this subsection if:

18 1. during any taxable year after the qualified business entity
19 is certified for the tax credit, the number of qualified positions filled by the qualified
20 business entity falls below 25, but does not fall below 10; and

21 2. the qualified business entity has maintained at least 25
22 qualified positions for at least 5 years.

23 (ii) The prorated share of the credit is calculated based on the
24 number of qualified positions filled for the taxable year divided by 25.

25 (e) A qualified business entity shall attach the certification required under §
26 6-402(a) of this subtitle to the tax return on which the start-up tax credit is claimed.]

27 [6-405.

28 If the pay for the majority of the qualified positions created from the establishment
29 or expansion of a business facility is at least 250% of the federal minimum wage, §§ 6-403(f)
