1 Article - Alcoholic Beverages 2 22 - 102.3 This title applies only in Harford County. 4 22-1006.5 (a) (1) In this section the following words have the meanings indicated. 6 "Concession manager" means a person that provides and supervises (2)7 under contract the comprehensive management of all food and beverage concession sales 8 on the licensed premises. 9 "Licensed premises" includes the stadium facility and stadium parking (3) 10 lots. 11 (b) There is a stadium beer, wine, and liquor license. 12 The Board may issue the license for a stadium owned by the City of Aberdeen 13 to the owner, lessee, or concession manager of a professional baseball stadium. 14 (d) Subject to paragraph (2) of this subsection, the license authorizes the 15 license holder to sell beer, wine, and liquor for on-premises consumption. 16 The license holder may sell, serve, or allow the consumption of beer, wine, and liquor on the stadium parking lots only with the prior written approval of the 17 18 Board. 19 (e) Subject to paragraph (2) of this subsection, the license holder may sell (1) 20beer, wine, and liquor on Monday through Sunday, from 8 a.m. to 2 a.m. the following day. 21(2)During a baseball game, a holder of a stadium license may not sell beer, 22wine, or liquor: 23(i) after the beginning of the eighth inning; or 24(ii) during a doubleheader game, after the beginning of the sixth 25 inning of the second game. 26 An individual who serves beer, wine, and liquor on the licensed 27 premises shall hold a certificate from an alcohol awareness program that the Board 28 approves.

29 (2) [An individual may serve liquor during a baseball game only on the club 30 level or in a dining area where patrons are seated.

1 2 3	(3)] (i) Except as provided in subparagraph (ii) of this paragraph, an individual may serve beer, wine, and liquor during a baseball game only in a plastic, Styrofoam, or paper container.
4 5	(ii) An individual may serve beer, wine, and liquor in a glass container on the club level or in a dining area where patrons are seated.
6 7	[(4)](3) (i) This paragraph does not apply to [beer and] wine AND LIQUOR served on the club level or in a dining area where patrons are seated.
8 9 10	(ii) An individual may dispense [beer and] wine AND LIQUOR during a baseball game only from a stationary structure that is in the stadium and equipped with a motor vehicle driver's license scanner.
11 12	[(5)](4) A license holder may not allow a roving vendor to dispense [beer,] wine[,] and liquor.
13 14	[(6)](5) A license holder may not allow a person to carry beer, wine, and liquor onto or off of the licensed premises.
15	(g) The annual license fee is \$10,000.
16 17	SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July 1, 2018.
