BY repealing and reenacting, with amendments, The Public Local Laws of Calvert County Section 6–101 Article 5 – Public Local Laws of Maryland (2002 Edition and August 2017 Supplement) Preamble WHEREAS, Calvert County is currently required to purchase advertising in local newspapers when inviting proposals for contracts; and WHEREAS, Calvert County spends more than \$17,000 per year on such advertising: and WHEREAS, Calvert County seeks to invite proposals for contracts by making such invitations available to the widest possible audience; and

8 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, 9 That the Laws of Maryland read as follows:

Article 5 – Calvert County

 - (a) Except as otherwise provided in this title, contracts for the purchase by the county of supplies or services involving \$15,000 or more shall be by formal bidding procedures and the contract shall be awarded at a regularly scheduled meeting of the Commissioners or by the official authorized to contract for the county to the lowest responsible bidder meeting specifications. A contract may not be subdivided to avoid the requirements of this section.
- 18 (b) The Commissioners or the official authorized to contract for the county shall 19 invite proposals for all contracts subject to this section by [publishing a notice in at least 20 two county newspapers for two consecutive weeks. The notice shall state that in not less 21than three weeks the Commissioners or the official authorized to contract for the county 22will meet in public session to receive bids for the described purchase or contract, state the time and place of the meeting, and reserve the right to reject any and all bids PUBLISHING 2324NOTICE IN EMARYLAND MARKETPLACE AND IN OTHER FORMS OF SOCIAL MEDIA OR 25 WEBSITES WHERE THE COUNTY MAINTAINS A PRESENCE. THE COMMISSIONERS OR 26 THE OFFICIAL AUTHORIZED TO CONTRACT FOR THE COUNTY MAY USE OTHER 27 METHODS TO INVITE PROPOSALS FOR CONTRACTS SUBJECT TO THIS SECTION.
- 28 (c) In determining the "lowest responsible bidder," in addition to considering 29 price, the Commissioners or the official authorized to contract for the county shall consider:
- 30 (1) The ability, capacity, and skill of the bidder to perform the contract or 31 provide the service required;
- 32 (2) Whether the bidder can perform the contract or provide the service 33 promptly, or within the time specified, without delay or interference;
- 34 (3) The character, integrity, reputation, judgment, experience, and 35 efficiency of the bidder;
