## A BILL ENTITLED

## 2 Maryland Cooperative Housing Act – Dispute Settlement and Eviction 3 Procedures

4 FOR the purpose of specifying that a certain dispute settlement mechanism does not apply 5 to complaints or demands arising out of a cooperative housing member's failure to 6 pay certain assessments; repealing a requirement that the governing body of a 7 cooperative housing corporation hold a hearing on a certain alleged violation under 8 certain circumstances; authorizing a member to request a hearing on a certain 9 alleged violation under certain circumstances; authorizing a governing body of a 10 cooperative housing corporation to impose a certain sanction without additional 11 process if a member does not request a hearing within a certain time frame; altering 12 requirements for certain notices relating to certain alleged violations; repealing a 13 provision requiring the governing body of a cooperative housing corporation to place 14 proof of a certain notice in the minutes of a certain meeting before imposing any 15 sanction on a member; repealing a provision prohibiting the governing body of a certain cooperative housing corporation from bringing an action in court to evict a 16 17 member based on the member's failure to pay certain assessments except under 18 certain circumstances; and generally relating to cooperative housing corporations.

## 1 WITHOUT THE NEED FOR ADDITIONAL PROCESS.

- 2 (c) A member may appeal a decision of a governing body made in accordance with 3 the dispute settlement procedure described in this section to the courts of Maryland.
  - (d) (1) If a member fails to comply with this subtitle, the bylaws of a cooperative housing corporation, or a decision rendered by the governing body in accordance with this section, the governing body or any other member of the cooperative housing corporation may sue the member for any damages caused by the failure or for injunctive relief.
- 9 (2) The prevailing party in a proceeding authorized under this subsection 10 is entitled to an award for reasonable attorney's fees as determined by court.
- 11 (e) The failure of a governing body to enforce a provision of this title, the 12 proprietary lease of a member, or the bylaws of the cooperative housing corporation on any 13 occasion is not a waiver of the right to enforce the provision on any other occasion.

- 15 (a) This section applies only to a cooperative project that is no longer subject to a 16 mortgage or deed of trust.
- 17 (b) Notwithstanding the articles of incorporation, bylaws, or regulations of a 18 cooperative housing corporation or the proprietary lease of any member, a governing body 19 may not bring an action in court to evict a member based solely on the failure of the member 20 to pay assessments owed to the cooperative housing corporation unless:
- 21 (1) The member has been delinquent in paying assessments for a period of 22 3 months or more;
- 23 (2) The governing body has given the member notice and an opportunity to 24 be heard regarding the delinquency, consistent with § 5–6B–30 of this subtitle;
- 25 (3) The governing body has given the member an opportunity to cure the 26 delinquency; and
- 27 (4) The member has failed to cure the delinquency.
- SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect 29 October 1, 2018.
