## Maryland Chiropractic Act - Revisions

FOR the purpose of repealing a requirement that the State Board of Chiropractic Examiners issue paper copies of licenses; prohibiting, under certain circumstances, an applicant for a license to practice chiropractic from being required under a certain provision of law to hold a bachelor's degree; altering the number of sets of fingerprints a certain applicant for licensure is required to submit to the Criminal Justice Information System Central Repository of the Department of Public Safety and Correctional Services; requiring the Central Repository to forward to the Board certain information regarding a certain applicant's criminal history record information under certain circumstances; repealing the authority of the Board to accept, under certain circumstances, an alternate method of criminal history records check as approved by the Director of the Central Repository and the Director of the Federal Bureau of Investigation; authorizing the Board to grant an extern license to an individual who meets certain requirements; establishing the qualifications for an extern license; providing for the term and termination of an extern license; requiring the Board to maintain an electronic roster of certain individuals licensed by the Board; requiring the electronic roster to be available on the Board's website; authorizing certain individuals to contact the Board to verify a license; requiring a certain electronic license record to include certain information; requiring certain applicants and licensees to submit to a mental health or physical examination under certain circumstances; providing that certain applicants or licensees are deemed to have consented to a certain mental health examination and waived certain claims


