1 AN ACT concerning

State Commission of Real Estate Appraisers, Appraisal Management Companies, and Home Inspectors – Membership

4 FOR the purpose of repealing the requirement that certain licensed home inspector
5 members of the State Commission of Real Estate Appraisers, Appraisal Management
6 Companies, and Home Inspectors be members of a certain home inspection
7 organization or society; and generally relating to the membership of the State
8 Commission of Real Estate Appraisers, Appraisal Management Companies, and
9 Home Inspectors.

20 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,

1 That the Laws of Maryland read as follows:

2 **Article – Business Occupations and Professions**

3 16–101.

4 (a) In this title the following words have the meanings indicated.

5 (h) “Commission” means the State Commission of Real Estate Appraisers,
6 Appraisal Management Companies, and Home Inspectors.

7 16–202.

8 (a) (1) The Commission consists of 15 members.

9 (2) Of the 15 members of the Commission:

10 (i) at least 2 shall be certified general real estate appraisers;

11 (ii) 2 shall be certified general real estate appraisers, certified
12 residential real estate appraisers, or licensed real estate appraisers;

13 (iii) 2 shall be representatives of a financial institution who are not
14 certified or licensed real estate appraisers or home inspectors;

15 [(iv) 1 shall be a licensed home inspector who is a member of the
16 American Society of Home Inspectors (ASHI);

17 [(v) 1 shall be a licensed home inspector who is a member of the
18 National Association of Home Inspectors;]

19 [(vi)] (IV) [2] 4 shall be licensed home inspectors [without regard to
20 affiliation with or membership in any society or association];

21 [(vii)] (V) 4 shall be consumer members; and

22 [(viii)] (VI) 1 shall be a representative of an appraisal management
23 company registered under Subtitle 5B of this title.

24 (3) The Governor shall:

25 (i) appoint the members with the advice of the Secretary and with
26 the advice and consent of the Senate; and

27 (ii) consider demographic and geographic diversity when making
28 appointments to the Commission.

1 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
2 October 1, 2018.
