CHAPTER _____

1 AN ACT concerning

2 **Harford County Sheriff – Deputy Sheriffs and Correctional Officers – Collective**
3 **Bargaining**

4 FOR the purpose of providing that certain deputy sheriffs and correctional officers in the
5 Office of the Sheriff of Harford County have the right to organize and negotiate with
6 the Harford County Executive and Harford County Sheriff with regard to certain
7 wages and employee health care premium share; requiring the right to organize and
8 negotiate to be conducted in accordance with certain provisions of the Harford
9 County Code unless otherwise provided in this Act; requiring the terms of any
10 agreement with regard to certain wages and employee health care premium share to
11 be set forth in a memorandum of agreement entered into between the Sheriff, the
12 County Executive, and the employee organization; providing that an agreement with
13 regard to certain wages and employee health care premium share is not effective
14 until the agreement is ratified by the Sheriff, the County Executive, and the
15 employee organization; providing that a modification to an existing memorandum of
16 agreement is not valid except under certain circumstances; requiring certain
17 procedures set forth in the Harford County Code to apply if certain parties are unable
18 to reach a certain agreement; and generally relating to the salaries and negotiation
19 rights of sworn law enforcement officers and correctional officers of the Harford
20 County Sheriff's Office.

3 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
4 That the Laws of Maryland read as follows:

5 **Article – Courts and Judicial Proceedings**

6 2–309.

7 (n) **(9) (I) THIS PARAGRAPH APPLIES ONLY TO ALL FULL-TIME**
8 **DEPUTY SHERIFFS IN THE OFFICE OF THE SHERIFF OF HARFORD COUNTY AT THE**
9 **RANK OF CAPTAIN AND BELOW.**

10 **(II) SWORN LAW ENFORCEMENT OFFICERS SUBJECT TO THIS**
11 **PARAGRAPH SHALL HAVE THE RIGHT TO ORGANIZE AND NEGOTIATE WITH THE**
12 **HARFORD COUNTY EXECUTIVE AND THE HARFORD COUNTY SHERIFF WITH**
13 **REGARD TO WAGES AND EMPLOYEE HEALTH CARE PREMIUM SHARE NOT**
14 **REGULATED BY THE SHERIFF.**

15 **(III) UNLESS OTHERWISE PROVIDED IN THIS PARAGRAPH, THE**
16 **RIGHT TO ORGANIZE AND NEGOTIATE SHALL BE CONDUCTED IN ACCORDANCE WITH**
17 **§§ 38–5 THROUGH 38–8 OF CHAPTER 38, ARTICLE I OF THE HARFORD COUNTY**
18 **CODE.**

19 **(IV) THE TERMS OF ANY AGREEMENT WITH REGARD TO WAGES**
20 **AND EMPLOYEE HEALTH CARE PREMIUM SHARE NOT REGULATED BY THE SHERIFF**
21 **SHALL BE SET FORTH IN A MEMORANDUM OF AGREEMENT ENTERED INTO BETWEEN**
22 **THE SHERIFF, THE COUNTY EXECUTIVE, AND THE EMPLOYEE ORGANIZATION.**

23 **(V) AN AGREEMENT WITH REGARD TO WAGES AND EMPLOYEE**
24 **HEALTH CARE PREMIUM SHARE NOT REGULATED BY THE SHERIFF IS NOT**
25 **EFFECTIVE UNTIL THE AGREEMENT IS RATIFIED BY:**

- 26 **1. THE SHERIFF;**
27 **2. THE COUNTY EXECUTIVE; AND**
28 **3. THE EMPLOYEE ORGANIZATION.**

29 **(VI) A MODIFICATION TO AN EXISTING MEMORANDUM OF**
30 **AGREEMENT IS NOT VALID UNLESS THE MODIFICATION IS IN WRITING AND RATIFIED**
31 **BY:**

- 1 1. **THE SHERIFF;**
- 2 2. **THE COUNTY EXECUTIVE; AND**
- 3 3. **THE EMPLOYEE ORGANIZATION.**

4 (VII) IF THE SHERIFF, THE COUNTY EXECUTIVE, AND THE
5 EMPLOYEE ORGANIZATION ARE UNABLE TO REACH AN AGREEMENT BY THE DATES
6 SET IN CHAPTER 38, ARTICLE I OF THE HARFORD COUNTY CODE, THE
7 PROCEDURES SET FORTH IN § 38-8(B) OF THE HARFORD COUNTY CODE SHALL
8 APPLY, WITH THE COUNTY EXECUTIVE AND THE EMPLOYEE ORGANIZATION AS
9 PARTIES TO THE PROCEEDINGS DESCRIBED UNDER § 38-8(B) OF THE HARFORD
10 COUNTY CODE.

11 (10) (I) THIS PARAGRAPH APPLIES ONLY TO ALL FULL-TIME
12 CORRECTIONAL OFFICERS IN THE OFFICE OF THE SHERIFF OF HARFORD COUNTY
13 AT THE RANK OF CAPTAIN AND BELOW.

14 (II) CORRECTIONAL OFFICERS SUBJECT TO THIS PARAGRAPH
15 SHALL HAVE THE RIGHT TO ORGANIZE AND NEGOTIATE WITH THE HARFORD
16 COUNTY EXECUTIVE AND THE HARFORD COUNTY SHERIFF WITH REGARD TO
17 WAGES AND EMPLOYEE HEALTH CARE PREMIUM SHARE NOT REGULATED BY THE
18 SHERIFF.

19 (III) UNLESS OTHERWISE PROVIDED IN THIS PARAGRAPH, THE
20 RIGHT TO ORGANIZE AND NEGOTIATE SHALL BE CONDUCTED IN ACCORDANCE WITH
21 §§ 38-5 THROUGH 38-8 OF CHAPTER 38, ARTICLE I OF THE HARFORD COUNTY
22 CODE.

23 (IV) THE TERMS OF ANY AGREEMENT WITH REGARD TO WAGES
24 AND EMPLOYEE HEALTH CARE PREMIUM SHARE NOT REGULATED BY THE SHERIFF
25 SHALL BE SET IN A MEMORANDUM OF AGREEMENT ENTERED INTO BETWEEN THE
26 SHERIFF, THE COUNTY EXECUTIVE, AND THE EMPLOYEE ORGANIZATION.

27 (V) AN AGREEMENT WITH REGARD TO WAGES AND EMPLOYEE
28 HEALTH CARE PREMIUM SHARE NOT REGULATED BY THE SHERIFF IS NOT
29 EFFECTIVE UNTIL THE AGREEMENT IS RATIFIED BY:

- 30 1. **THE SHERIFF;**
- 31 2. **THE COUNTY EXECUTIVE; AND**
- 32 3. **THE EMPLOYEE ORGANIZATION.**

1 (VI) A MODIFICATION TO AN EXISTING MEMORANDUM OF
2 AGREEMENT IS NOT VALID UNLESS THE MODIFICATION IS IN WRITING AND RATIFIED
3 BY:

- 4 1. THE SHERIFF;
- 5 2. THE COUNTY EXECUTIVE; AND
- 6 3. THE EMPLOYEE ORGANIZATION.

7 (VII) IF THE SHERIFF, THE COUNTY EXECUTIVE, AND THE
8 EMPLOYEE ORGANIZATION ARE UNABLE TO REACH AN AGREEMENT BY THE DATES
9 SET IN CHAPTER 38, ARTICLE I OF THE HARFORD COUNTY CODE, THE
10 PROCEDURES SET FORTH IN § 38-8(B) OF THE HARFORD COUNTY CODE SHALL
11 APPLY, WITH THE COUNTY EXECUTIVE AND THE EMPLOYEE ORGANIZATION AS
12 PARTIES TO THE PROCEEDINGS DESCRIBED UNDER § 38-8(B) OF THE HARFORD
13 COUNTY CODE.

14 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July
15 1, 2018.
