CHAPTER _____

1 AN ACT concerning

2 **Frederick County – Alcoholic Beverages – Arena License**

3 FOR the purpose of establishing in Frederick County a Class B–A (arena) beer and wine
4 license; specifying that the license authorizes the license holder to sell beer and wine
5 by the drink on the campus of an institution of higher education from one or more
6 outlets that the Board of License Commissioners approves and for on–premises
7 consumption at sporting and nonsporting events held at the institution; requiring
8 the Board to adopt certain regulations; and generally relating to alcoholic beverages
9 licenses in Frederick County.

4 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
5 That Section(s) 20–1001, 20–1001.1, and 20–1001.2, respectively, of Article – Alcoholic
6 Beverages of the Annotated Code of Maryland be renumbered to be Section(s) 20–1001.1,
7 20–1001.2, and 20–1001.3, respectively.

8 SECTION 2. AND BE IT FURTHER ENACTED, That the Laws of Maryland read
9 as follows:

10 **Article – Alcoholic Beverages**

11 20–102.

12 This title applies only in Frederick County.

13 **20–1001.**

14 **(A) THERE IS A CLASS B–A (ARENA) BEER AND WINE LICENSE.**

15 **(B) THE LICENSE AUTHORIZES THE LICENSE HOLDER TO SELL BEER AND**
16 **WINE BY THE DRINK ON THE CAMPUS OF AN INSTITUTION OF HIGHER EDUCATION:**

17 **(1) FROM ONE OR MORE OUTLETS THAT THE BOARD APPROVES; AND**

18 **(2) FOR ON–PREMISES CONSUMPTION AT SPORTING AND**
19 **NONSPORTING EVENTS HELD AT THE INSTITUTION.**

20 **(C) THE BOARD SHALL ADOPT REGULATIONS CONCERNING THE MANNER**
21 **OF DISPENSING BEER AND WINE, THE HOURS AND DAYS OF SALE, AND THE ANNUAL**
22 **LICENSE FEE.**

23 SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect July
24 1, 2018.
