A BILL ENTITLED

1 AN ACT concerning

Washington County - Alcoholic Beverages - Per Diem Licenses

3 FOR the purpose of repealing the Class C per diem beer, Class C per diem beer and wine, and Sunday picnic licenses in Washington County; altering the requirements for a 4 5 Class C per diem beer, wine, and liquor license in Washington County to authorize 6 the license to be issued to a certain corporation, society, organization, association, or 7 other entity that meets certain requirements; altering the privileges of the license to 8 authorize a license holder to sell or serve beer, wine, or liquor for on-premises 9 consumption during a certain event; authorizing the Board of License Commissioners to issue multiple licenses to a single applicant; requiring a separate 10 11 license for each day of an event; altering the number of consecutive days for which 12 the Board may issue the license; requiring an applicant for the license to provide 13 certain documentation; establishing certain qualifications for individuals applying 14 for the license; specifying certain conditions under which a license holder may serve 15 or sell alcoholic beverages during a certain event; requiring alcoholic beverages sold 16 under the license to be purchased from a licensed wholesaler or retail dealer; 17 prohibiting a licensed wholesaler from donating alcoholic beverages to the license 18 holder; requiring the license holder to submit a certain financial statement within a 19 certain time; altering the days and hours during which a license holder may exercise 20 the privileges of the license; altering the fee for the license; making certain 21 conforming changes; and generally relating to alcoholic beverages licenses in 22 Washington County.

- 11 (b) The Board may issue the license to:

- 13 USE AT A PLACE OTHER THAN THE LICENSE HOLDER'S REGULAR PLACE OF
- 14 BUSINESS; OR
- 15 (2) A CORPORATION, A SOCIETY, AN ORGANIZATION, AN
- 16 ASSOCIATION, OR ANY OTHER ENTITY THAT DOES NOT HAVE AN ANNUAL ON-SALE
- 17 BEER, WINE, AND LIQUOR LICENSE AND HAS:
- 18 (I) NONPROFIT STATUS; OR
- 19 (II) A FEDERAL IDENTIFICATION NUMBER ASSIGNED BY THE
- 20 INTERNAL REVENUE SERVICE.
- 21 (c) The license AUTHORIZES THE LICENSE holder [may] TO sell OR SERVE beer,
- 22 wine, and liquor FOR ON-PREMISES CONSUMPTION at [a place other than the license
- 23 holder's regular place of business] THE PLACE DESCRIBED IN THE LICENSE DURING AN
- 24 EVENT THAT REQUIRES AN ADMISSION FEE, A TICKET, OR A DONATION.
- 25 (d) (1) SUBJECT TO PARAGRAPH (3) OF THIS SUBSECTION, THE BOARD
- 26 MAY ISSUE MULTIPLE CLASS C PER DIEM BEER, WINE, AND LIQUOR LICENSES TO A
- 27 SINGLE APPLICANT.
- 28 (2) A SEPARATE CLASS C PER DIEM BEER, WINE, AND LIQUOR
- 29 LICENSE IS REQUIRED FOR EACH DAY OF A MULTIPLE DAY EVENT.
- 30 (3) The Board may not issue the CLASS C PER DIEM BEER, WINE, AND

- 1 LIQUOR license for more than [5] 7 consecutive days.
- 2 (E) (1) AN APPLICANT FOR THE LICENSE SHALL:
- 3 (I) SUBMIT AN APPLICATION ON THE FORM THAT THE BOARD
- 4 PROVIDES; AND
- 5 (II) PROVIDE PROOF THAT THE APPLICANT HAS:
- 6 NONPROFIT STATUS; OR
- 7 2. A FEDERAL IDENTIFICATION NUMBER ASSIGNED BY
- 8 THE INTERNAL REVENUE SERVICE.
- 9 (2) (I) A LICENSE SHALL BE APPLIED FOR AND ISSUED TO THREE
- 10 INDIVIDUALS AFFILIATED WITH THE APPLICANT, EACH OF WHOM:
- 1. APPEARS IN PERSON TO PRESENT PROPER
- 12 QUALIFICATIONS AT THE TIME THE APPLICATION IS FILED;

- 3. IS A REGISTERED VOTER IN THE COUNTY AND A

- 21 DISTRIBUTE A WRISTBAND TO EACH INDIVIDUAL WHO IS AT LEAST 21 YEARS OLD;

- 23 (2) MAY NOT SERVE BEER, WINE, OR LIQUOR TO AN INDIVIDUAL WHO
- 24 DOES NOT WEAR A WRISTBAND.
- 25 (G) AT ALL TIMES DURING THE EVENT, THE LICENSE HOLDER SHALL
- 26 ENSURE THAT:
- 27 (1) ONE CERTIFIED CROWD CONTROL MANAGER WHO HAS OBTAINED
- 28 A CROWD CONTROL TRAINING CERTIFICATE FROM A PROGRAM THAT IS CERTIFIED

- 1 BY THE BOARD IS ON THE LICENSED PREMISES FOR EVERY 250 INDIVIDUALS 2 PRESENT; AND
- 3 (2) ONE INDIVIDUAL WHO HAS COMPLETED A CERTIFIED ALCOHOL 4 AWARENESS PROGRAM IS ON THE LICENSED PREMISES.
- 5 (H) (1) ALCOHOLIC BEVERAGES SOLD UNDER THE LICENSE SHALL BE 6 PURCHASED BY THE LICENSE HOLDER FROM A LICENSED WHOLESALER OR RETAIL 7 DEALER.
- 8 (2) A LICENSED WHOLESALER MAY NOT DONATE ALCOHOLIC 9 BEVERAGES TO THE LICENSE HOLDER.
- 10 (I) WITHIN 30 DAYS AFTER AN EVENT, THE LICENSE HOLDER SHALL 11 SUBMIT TO THE BOARD A SIGNED AND NOTARIZED FINANCIAL STATEMENT 12 SHOWING:
- 13 (1) THE TOTAL AMOUNT OF PROCEEDS FROM THE EVENT; AND
- 14 (2) THE DISBURSEMENT OF THE PROCEEDS.
- 15 (J) A LICENSE HOLDER MAY SELL OR SERVE BEER, WINE, AND LIQUOR:
- 16 (1) ON MONDAY THROUGH SATURDAY, FROM 10 A.M. TO 2 A.M. THE FOLLOWING DAY; OR
- 18 (2) ON SUNDAY, FROM NOON TO MIDNIGHT.

- 20 (1) A picnic license authorizes a club owner to sell beer at a place other 21 than the club owner's regular place of business.
- 22 (2) The license may be exercised only on Sunday between noon and 23 midnight.]

- 27 (2) \$25 per day for a Class C per diem beer and wine license;

- 1 (3) \$30 per day for a Class C per diem beer, wine, and liquor license, except there is no fee on Sunday; and
- 3 (4) \$15 per day for a "picnic" license] FEE FOR A CLASS C PER DIEM 4 BEER, WINE, AND LIQUOR LICENSE IS \$100 PER DAY.
