## CHAPTER \_\_\_\_\_

1 AN ACT concerning

2 **Video Lottery Terminal Revenues – Purse Dedication Account – Standardbred**  
3 **Racetrack Operating Loss Assistance**

4 FOR the purpose of providing for certain calendar years the authorization to use certain  
5 Purse Dedication Account funds generated from video lottery proceeds for operating  
6 loss assistance by the Ocean Downs Race Course and Rosecroft Raceway to support  
7 a minimum number of annual live racing days at each race course; and generally  
8 relating to the use of Purse Dedication Account funds by the Ocean Downs Race  
9 Course and Rosecroft Raceway for operating loss assistance.

12 Section 9–1A–27(a)(4) and 9–1A–28(a) and (e)(1)

20 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,

1 That the Laws of Maryland read as follows:

2 **Article – State Government**

3 9–1A–27.

4 (a) Except as provided in subsections (b) and (c) of this section and §  
5 9–1A–26(a)(3) of this subtitle, on a properly approved transmittal prepared by the  
6 Commission, the Comptroller shall pay the following amounts from the proceeds of video  
7 lottery terminals at each video lottery facility:

8 (4) 6% to the Purse Dedication Account established under § 9–1A–28 of this  
9 subtitle, not to exceed a total of \$100,000,000 to the Account annually;

10 9–1A–28.

11 (a) There is a Purse Dedication Account under the authority of the State Racing  
12 Commission.

13 (e) The amount of funds allocated to standardbred purses and the Standardbred  
14 Race Fund shall be allocated as follows:

15 (1) 89% to standardbred purses at Rosecroft Raceway, Ocean Downs Race  
16 Course, and the racecourse in Allegany County, allocated based on the number of live racing  
17 days at each track location; and

18 (g) (1) Of the amount provided from the Purse Dedication Account under  
19 subsection (e)(1) of this section:

20 (i) for Ocean Downs Race Course, up to \$1,200,000 each year for  
21 calendar years [2015, 2016, 2017,] 2018, [and] 2019, **2020, 2021, 2022, 2023, AND 2024**  
22 may be used to provide financial assistance for operating losses, in accordance with  
23 generally accepted accounting principles, to support a minimum of 40 annual live racing  
24 days [for calendar years 2015, 2016, 2017, 2018, and 2019] unless the racing licensee is  
25 prevented by weather, acts of God, or other circumstances beyond the racing licensee's  
26 control; and

27 (ii) for Rosecroft Raceway, up to \$1,200,000 each year for calendar  
28 years [2015, 2016, 2017,] 2018, [and] 2019, **2020, 2021, 2022, 2023, AND 2024** may be  
29 used to provide financial assistance for operating losses, in accordance with generally  
30 accepted accounting principles, to support a minimum of 40 annual live racing days [for  
31 calendar years 2015, 2016, 2017, 2018, and 2019] unless the racing licensee is prevented  
32 by weather, acts of God, or other circumstances beyond the racing licensee's control.

33 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect  
34 October 1, 2018.
