## CHAPTER \_\_\_\_\_

1 AN ACT concerning

2 **Landlord and Tenant – Residential Leases – Water and Sewer Bills**

3 FOR the purpose of requiring a certain landlord to use a written lease that includes a  
4 certain notice and to provide a copy of a certain water or sewer bill to a tenant under  
5 certain circumstances; defining a certain term; providing for the application of this  
6 Act; and generally relating to residential leases.

12 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,  
13 That the Laws of Maryland read as follows:

14 **Article – Real Property**

15 **8–205.1.**

16 **(A) IN THIS SECTION, “UTILITY SERVICE PROVIDER” MEANS A PUBLIC**  
17 **SERVICE COMPANY OR A UNIT OF STATE OR LOCAL GOVERNMENT THAT PROVIDES**  
18 **WATER OR SEWER UTILITY SERVICES.**

1 (B) (1) THIS SECTION APPLIES ONLY TO A LANDLORD OF A BUILDING  
2 THAT CONTAINS ONE OR TWO RESIDENTIAL DWELLING UNITS.

3 (2) THIS SECTION DOES NOT APPLY TO A LANDLORD THAT REQUIRES  
4 A TENANT, UNDER AN ORAL OR WRITTEN LEASE, TO PAY WATER OR SEWER BILLS  
5 DIRECTLY TO THE UTILITY SERVICE PROVIDER.

6 (C) A LANDLORD THAT REQUIRES A TENANT TO MAKE PAYMENTS FOR  
7 WATER OR SEWER UTILITY SERVICES TO THE LANDLORD SHALL:

8 (1) USE A WRITTEN LEASE THAT PROVIDES NOTICE THAT THE  
9 TENANT IS RESPONSIBLE FOR MAKING PAYMENTS FOR WATER OR SEWER UTILITY  
10 SERVICES TO THE LANDLORD; AND

11 (2) ~~ON THE REQUEST OF THE TENANT, PROVIDE~~ PROVIDE A COPY OF  
12 THE WATER OR SEWER BILL TO THE TENANT.

13 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect  
14 October 1, 2018.
