## A BILL ENTITLED

1 AN ACT concerning

2 **Higher Education – Financial Aid – In-State Students**  
3 **(The Jill Wrigley Memorial Scholarship Expansion Act)**

4 FOR the purpose of making a certain individual eligible for certain financial aid if the  
5 individual is eligible for certain in-State tuition; and generally relating to financial  
6 aid for in-State students.

17 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,  
18 That the Laws of Maryland read as follows:

21 (a) Subject to subsection (d) of this section, each recipient of a Delegate Howard  
22 P. Rawlings Educational Excellence Award shall:

1 eligible institution or be enrolled in a 2-year associate degree program in which the course  
2 work is acceptable for transfer credit for an accredited baccalaureate program in an eligible  
3 institution;

4 (2) [Be] EXCEPT AS PROVIDED IN § 18-303.2 OF THIS SUBTITLE, BE a  
5 resident of this State;

6 (3) Demonstrate to the Office a definite financial need; and

7 (4) Accept any other conditions attached to the award.

10 ELIGIBLE FOR AN AWARD UNDER THIS SUBTITLE IF THE INDIVIDUAL IS ELIGIBLE  
11 FOR IN-STATE TUITION UNDER THIS ARTICLE.

13 (c) A recipient of a part-time grant shall:

14 (1) [Be] EXCEPT AS PROVIDED IN § 18-1401.1 OF THIS SUBTITLE, BE  
15 a resident of the State; and

16 (2) Have demonstrated a definite financial need according to criteria  
17 established by the Commission.

19 NOTWITHSTANDING § 18-1401(C)(1) OF THIS SUBTITLE, AN INDIVIDUAL IS  
20 ELIGIBLE FOR AN AWARD UNDER THIS SUBTITLE IF THE INDIVIDUAL IS ELIGIBLE  
21 FOR IN-STATE TUITION UNDER THIS ARTICLE.

22 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July  
23 1, 2018.
