2 Public Health – Sepsis Public Awareness Campaign Workgroup

- FOR the purpose of requiring the Secretary of Health to establish a Sepsis Public
 Awareness Campaign Workgroup; providing for the membership of the Workgroup;
 requiring the Workgroup to develop a certain public awareness campaign, identify,
 review, and evaluate certain resources, and identify cost-effective methods for
 disseminating certain information; requiring the Workgroup to report to certain
 committees of the General Assembly on or before a certain date; and generally
 relating to a Sepsis Public Awareness Campaign Workgroup.

11 WHEREAS, Sepsis is a serious and often fatal clinical syndrome, resulting from 12 infection; and

13 WHEREAS, Sepsis is a leading cause of deaths in hospitals and a leading cause of 14 preventable deaths in children; and

15 WHEREAS, Sepsis affects more than 1 million Americans each year at an annual 16 cost of over \$20 billion; and

WHEREAS, Early recognition and intensive treatment are critical to decreasingmorbidity and mortality from sepsis; and

1 WHEREAS, Public education about sepsis symptoms, diagnosis, treatment, and 2 preventive measures is lacking because sepsis is a clinical syndrome with many causes that 3 requires diagnosis by a physician; and

4 WHEREAS, Many different types of infections can lead to sepsis and a majority of 5 patients develop infections leading to sepsis outside a hospital; and

6 WHEREAS, Maryland needs a coordinated and comprehensive campaign to educate 7 the public on the need to prevent infections, the symptoms of sepsis, and the need for 8 immediate treatment if sepsis is suspected or for an infection that is not improving or is 9 getting worse; now, therefore,

10 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, 11 That:

12 (a) (1) The Secretary of Health shall establish a Sepsis Public Awareness 13 Campaign Workgroup.

(2) The Workgroup shall include the following members:

(i) two individuals who have had sepsis or have a family memberwho has had sepsis;

- 17 (ii) two representatives of hospitals;
- 18 (iii) one licensed emergency medicine physician;
- 19 (iv) one licensed primary care physician;
- 20 (v) one licensed pediatrician;
- 21 (vi) one representative of a local health department;
- 22 (vii) one representative of the Maryland Patient Safety Center;
- 23 (viii) one representative of the Maryland Nurses Association;
- 24 (ix) one representative from the Maryland State Department of 25 Education;
- 26 (x) one representative from the Maryland Department of Health;
- 27 (xi) one infection control professional; and
- 28 (xii) one individual with expertise in public communication.

29 (b) The Workgroup shall:

1 develop a public awareness campaign on sepsis awareness and (1) $\mathbf{2}$ prevention that includes: 3 a definition of sepsis; (i) 4 (ii) the risks associated with sepsis; $\mathbf{5}$ (iii) how sepsis may occur; 6 (iv) the signs and symptoms of sepsis; 7 what to do if symptoms of sepsis are present; and (v) 8 (vi) methods for prevention of sepsis; 9 (2)identify, review, and evaluate resources that could be used to educate 10 the public on sepsis; and 11 identify cost-effective methods for disseminating information to the (3)12public about sepsis. 13On or before December 1, 2018, the Workgroup shall report to the Senate (c) Finance Committee and the House Health and Government Operations Committee, in 14 15accordance with § 2-1246 of the State Government Article, on the public awareness campaign developed under subsection (b) of this section. 16 17SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect June 18 1, 2018.
