## A BILL ENTITLED

1 AN ACT concerning

2 **Commercial Driver's Licenses – Recognition, Prevention, and Reporting of**  
3 **Human Trafficking**

4 FOR the purpose of requiring the Motor Vehicle Administration to include questions on  
5 human trafficking recognition, prevention, and effective reporting as part of the  
6 commercial driver's license knowledge test; requiring commercial driver's license  
7 training schools to include training on human trafficking recognition, prevention,  
8 and effective reporting as part of the curriculum; requiring the Administration to  
9 include content on human trafficking recognition, prevention, and effective reporting  
10 in its Commercial Driver's License Manual; requiring the Administration to provide  
11 content on human trafficking recognition, prevention, and effective reporting from  
12 the Manual to applicants renewing their commercial driver's licenses; and generally  
13 relating to commercial driver's licenses.

24 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,  
25 That the Laws of Maryland read as follows:

26 **Article – Transportation**

2 (b) (1) Except as provided in § 16-807.1 of this subtitle, an individual may not  
3 be issued a commercial driver's license until the individual has passed the knowledge and  
4 skill tests for driving a commercial motor vehicle which complies with the minimum federal  
5 standards established by the federal Commercial Motor Vehicle Safety Act of 1986 (Title  
6 XII of Public Law 99-570), and has satisfied all other requirements of that act as well as  
7 any other requirements of this title.

8 (2) The tests shall be prescribed and conducted at the direction of the  
9 Administration **AND, IN ADDITION TO FEDERAL REQUIREMENTS, SHALL INCLUDE**  
10 **QUESTIONS ON THE RECOGNITION, PREVENTION, AND EFFECTIVE REPORTING OF**  
11 **HUMAN TRAFFICKING.**

12 (3) The Administration shall adopt regulations to waive the skill test  
13 required under paragraph (1) of this subsection in a manner consistent with 49 C.F.R. §  
14 383.77.

16 (A) **A COMMERCIAL DRIVER'S LICENSE TRAINING SCHOOL SHALL INCLUDE**  
17 **AS PART OF ITS CURRICULUM EDUCATION AND TRAINING ON THE RECOGNITION,**  
18 **PREVENTION, AND EFFECTIVE REPORTING OF HUMAN TRAFFICKING.**

19 (B) **THE ADMINISTRATION SHALL:**

20 (1) **INCLUDE AS PART OF ITS COMMERCIAL DRIVER'S LICENSE**  
21 **MANUAL CONTENT ON THE RECOGNITION, PREVENTION, AND EFFECTIVE**  
22 **REPORTING OF HUMAN TRAFFICKING; AND**

23 (2) **ON REQUEST, PROVIDE TO AN APPLICANT RENEWING A**  
24 **COMMERCIAL DRIVER'S LICENSE CONTENT FROM THE MANUAL ON THE**  
25 **RECOGNITION, PREVENTION, AND EFFECTIVE REPORTING OF HUMAN TRAFFICKING.**

26 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect  
27 October 1, 2018.
