SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That the Laws of Maryland read as follows:

Article – Criminal Procedure

- 16 (a) A notice shall be signed by the clerk and shall:
- 17 (1) include the caption of the case;
- 18 (2) describe the substance of the complaint and the relief sought;
- 19 (3) state the latest date on which a response may be filed;
- 20 (4) state that the property shall be forfeited if a response is not filed on 21 time;
