Veteran Suicide Prevention - Comprehensive Action Plan

3 FOR the purpose of requiring the Department of Veterans Affairs to develop a certain 4 action plan to increase access to and the availability of professional veteran health 5 services to prevent veteran suicides that includes certain initiatives and reforms and 6 a plan for implementation beginning on or before certain dates; requiring the plan 7 to address certain matters; requiring the Department to collaborate with interested 8 parties in developing the plan; requiring the Department to implement certain 9 initiatives and reforms by certain dates; requiring the Department to report to the 10 Governor and the General Assembly on or before a certain date; providing for the 11 termination of this Act; and generally relating to a comprehensive action plan for 12 veteran suicide prevention.

- 1 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
- 2 That the Laws of Maryland read as follows:

3 Article – State Government

- 5 (A) THE DEPARTMENT SHALL DEVELOP A COMPREHENSIVE ACTION PLAN
- 6 TO INCREASE ACCESS TO AND AVAILABILITY OF PROFESSIONAL VETERAN HEALTH
- 7 SERVICES TO PREVENT VETERAN SUICIDES THAT INCLUDES:
- 8 (1) SHORT-TERM INITIATIVES AND REFORMS AND A PLAN FOR STATE
- 9 IMPLEMENTATION BEGINNING ON OR BEFORE JULY 1, 2020; AND
- 10 (2) LONG-TERM INITIATIVES AND REFORMS AND A PLAN FOR STATE
- 11 IMPLEMENTATION BEGINNING ON OR BEFORE JULY 1, 2022.
- 12 (B) THE ACTION PLAN DEVELOPED UNDER SUBSECTION (A) OF THIS
- 13 SECTION SHALL:
- 14 (1) IDENTIFY OPPORTUNITIES FOR RAISING AWARENESS OF AND
- 15 PROVIDING RESOURCES FOR VETERAN SUICIDE PREVENTION;

- 30 (C) THE DEPARTMENT SHALL COLLABORATE WITH INTERESTED PARTIES

- 3 (1) THE MARYLAND DEPARTMENT OF HEALTH;

- 6 TECHNICAL ASSISTANCE CENTER IMPLEMENTATION ACADEMY OF THE

- 13 (D) (1) THE DEPARTMENT SHALL IMPLEMENT THE SHORT-TERM
- 14 INITIATIVES AND REFORMS IN THE PLAN DEVELOPED UNDER SUBSECTION (A)(1) OF
- 15 THIS SECTION ON OR BEFORE JUNE 30, 2022.
- 16 (2) THE DEPARTMENT SHALL IMPLEMENT THE LONG-TERM
- 17 INITIATIVES AND REFORMS IN THE PLAN REQUIRED UNDER SUBSECTION (A)(2) OF
- 18 THIS SECTION ON OR BEFORE JUNE 30, 2028.
- 19 SECTION 2. AND BE IT FURTHER ENACTED, That, on or before July 1, 2019, the
- 20 Department of Veterans Affairs shall report to the Governor and, in accordance with §
- 21 2-1246 of the State Government Article, the General Assembly on any statutory,
- 22 administrative, and budgetary changes that would need to be made to implement the
- 23 initiatives and reforms included in the action plan developed under § 9-947 of the State
- 24 Government Article, as enacted by Section 1 of this Act.
- 25 SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect July
- 26 1, 2018. It shall remain effective for a period of 10 years and, at the end of June 30, 2028,
- 27 this Act, with no further action required by the General Assembly, shall be abrogated and
- 28 of no further force and effect.
