3 (c) (1) In this subsection, “ASVAB” means the Armed Services Vocational
4 Aptitude Battery.

5 (2) Each public school in the State that administers the ASVAB shall
6 choose “Option 8” as the score reporting option for military recruiter contact to prohibit the
7 general release of any student information to military recruiters.

8 (3) Each public school that administers the ASVAB shall:

9 (i) Send a written notice to the ASVAB representative coordinating
10 the school’s administration of the ASVAB of the requirement set forth in paragraph (2) of
11 this subsection; and

12 (ii) Notify students taking the ASVAB and the parent or guardian of

2 THIRD-PARTY ENTITY USING PREDETERMINED STANDARDS FOR KNOWLEDGE AND

4 (F) "VOCATIONAL CERTIFICATE" MEANS A CERTIFICATE OR LICENSE

14 Commission, University System of Maryland, Morgan State University, St. Mary's College
15 of Maryland, and Department of Labor, Licensing, and Regulation jointly shall establish
16 the Maryland Longitudinal Data System that shall be fully operational by December 31,
17 2014.

18 (b) The Maryland Longitudinal Data System is a statewide data system that
19 contains individual-level student data and workforce data from all levels of education and
20 the State's workforce, and allows the Center to:

21 (1) Effectively organize, manage, disaggregate, and analyze individual
22 student data; and

23 (2) Examine student progress and outcomes over time, including
24 preparation for postsecondary education and the workforce.

25 (c) The linkage of student data and workforce data for the purposes of the
26 Maryland Longitudinal Data System shall be limited to no longer than 20 years from the
27 date of latest attendance in any educational institution in the State.

28 (d) The purpose of the Maryland Longitudinal Data System is to:

29 (1) Generate timely and accurate information about student performance
30 that can be used to improve the State's education system and guide decision makers at all
31 levels; and

1 (2) Facilitate and enable the linkage of student data and workforce data.
