# Disclosure of Tax Benefits – Nonprofit Hospitals

FOR the purpose of requiring each nonprofit hospital, each year, to submit to the Comptroller an itemized list of certain tax benefits; requiring the Comptroller to prepare a certain report and to post the report on the Comptroller's website; requiring the Comptroller, in consultation with certain employee organizations, to adopt certain regulations; defining a certain term; and generally relating to nonprofit hospitals and tax benefits provided under the tax laws of the State.

- SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
  That the Laws of Maryland read as follows:

## 18 (A) IN THIS SECTION, "HOSPITAL" HAS THE MEANING STATED IN § 19–301 19 OF THE HEALTH – GENERAL ARTICLE.

20 (B) EACH YEAR EACH NONPROFIT HOSPITAL SHALL SUBMIT TO THE 21 COMPTROLLER AN ITEMIZED LIST OF THE TAX BENEFITS THE HOSPITAL RECEIVED 22 DURING THE PREVIOUS TAXABLE YEAR.

(3) POST THE REPORT ON THE COMPTROLLER'S WEBSITE.

6 (D) THE COMPTROLLER, IN CONSULTATION WITH THE EMPLOYEE GROUP 7 DESIGNATED AS THE EXCLUSIVE REPRESENTATIVE FOR NONPROFIT HOSPITAL 8 EMPLOYEES, SHALL ADOPT REGULATIONS NECESSARY TO CARRY OUT THIS 9 SECTION, INCLUDING REGULATIONS THAT ESTABLISH:

10(1) FORMATTING STANDARDS FOR THE ITEMIZED LIST REQUIRED11UNDER THIS SECTION; AND

# 12(2)THE DATE EACH YEAR BY WHICH A NONPROFIT HOSPITAL MUST13SUBMIT THE ITEMIZED LIST REQUIRED UNDER THIS SECTION.

SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July1, 2018.
