## A BILL ENTITLED

1 AN ACT concerning

## Education – Teacher Certification – Montessori Schools

3 FOR the purpose of making an individual eligible for a certificate to teach students in a 4 Montessori school if the individual meets certain requirements; authorizing the  $\mathbf{5}$ State Board of Education to require an individual to successfully pass an 6 examination to be certified under this Act; providing that, subject to a certain 7 exception, an individual that satisfies the requirements under this Act may not be 8 required to meet any additional requirements to be certified to teach students in a 9 Montessori school; prohibiting an individual certified under this Act from teaching certain students under certain circumstances; defining a certain term; providing for 10 11 the application of this Act; and generally relating to teacher certification for teachers 12at Montessori schools.
