4 FOR the purpose of requiring the Board of License Commissioners for Baltimore City to
5 give notice to certain persons on or before a certain time regarding any legislative
6 proposal the Board intends to submit to the Baltimore City delegation to the General
7 Assembly for introduction as a bill; and generally relating to notice by the Board of
8 License Commissioners for Baltimore City regarding legislative proposals.

19 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
20 That the Laws of Maryland read as follows:

7 **AT LEAST 3 MONTHS BEFORE THE START OF THE REGULAR SESSION OF THE**
 8 **GENERAL ASSEMBLY EACH YEAR, THE BOARD SHALL GIVE NOTICE TO THE**
 9 **FOLLOWING PERSONS REGARDING ANY LEGISLATIVE PROPOSAL THE BOARD**
 10 **INTENDS TO SUBMIT TO THE CITY DELEGATION TO THE GENERAL ASSEMBLY FOR**
 11 **INTRODUCTION AS A BILL:**

12 **(1) THE MAYOR OF BALTIMORE CITY;**

13 **(2) THE PRESIDENT OF THE CITY COUNCIL; AND**

14 **(3) COMMUNITY AND RESIDENTIAL GROUPS IN THE CITY THAT HAVE**
 15 **OPTED TO RECEIVE NOTICES FROM THE BOARD.**

16 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July
 17 1, 2018.
