**Higher Education - Richard W. Collins III Leadership With Honor Scholarship - Establishment**

This bill establishes the Richard W. Collins III Leadership with Honor Scholarship Program. To be eligible, an individual must be (1) eligible for in-state tuition; (2) a member of a Reserve Officer Training Corps (ROTC) program; (3) a minority student or a student who is a member of another group historically underrepresented in ROTC programs; and (4) a student at a historically black college or university (HBCU) in the State. The Office of Student Financial Assistance (OSFA) within the Maryland Higher Education Commission (MHEC) must make the awards, following specified criteria, and must adopt procedures or regulations necessary to implement the bill. The Governor must include in the State budget an annual appropriation of at least \$1.0 million for the program. **The bill takes effect July 1, 2018.**

**Fiscal Summary**

**State Effect:** General fund expenditures increase by an estimated \$1.0 million in FY 2019 to establish the scholarship program and begin making awards. Annually thereafter, at least \$1.0 million must be provided for the program. Revenues are not affected. **This bill establishes a mandated appropriation beginning in FY 2020.**

## Analysis

### **Bill Summary:** OSFA must:

- award 25% of its total annual grant money to students at Bowie State University (BSU);
- award 75% of its total annual grant money to students at HBCUs other than BSU;
- determine the amount of each award;
- select the recipient of each award; and
- prioritize students with financial need in selecting recipients of each award.

### **Current Law/Background:**

#### *Richard W. Collins III*

Richard W. Collins III was an ROTC student at BSU. He was days from graduating from BSU with a business degree to join the U.S. Army when he was stabbed to death at a bus stop at the University of Maryland, College Park Campus in May 2017. According to his obituary, the 24-year-old was commissioned as a second lieutenant in the U.S. Army a few days before his death. In addition to his interest in the U.S. Army, Collins was instrumental in starting the first lacrosse team at BSU.

#### *Reserve Officer Training Corps*

ROTC is a group of college-based officer training programs for training commissioned officers of the U.S. Armed Forces. There are three separate ROTC programs run by the U.S. Armed Forces: Army ROTC; Navy ROTC, which also trains Marines Corps officers; and Air Force ROTC. The Coast Guard does not have an ROTC program, instead it has a split training program. There are [Army ROTC programs](#) at the following HBCUs in the State: BSU and Morgan State University (MSU). In addition, students at Coppin State University can take ROTC courses at MSU, and students at the University of Maryland Eastern Shore can take ROTC courses at the University of Delaware. There are no [Navy ROTC programs](#) at HBCUs in Maryland. BSU has the only [Air Force ROTC program](#) at an HBCU in the State.

There are military and college scholarships available to ROTC members. The amount of the scholarship depends on a number of factors, including the ROTC branch, the institution, and the number of years an individual has been in the program. For example, the Army ROTC program offers two-, three-, and four-year scholarships, which pay full tuition and fees, including a separate allowance for books and a monthly stipend of up to \$5,000 a year. Some institutions offer free room and board to ROTC scholarship recipients who

maintain a certain grade point average. However, ROTC scholarships are competitive, and not all individuals who participate in ROTC receive a scholarship.

ROTC programs also have service obligations. For example, for the Army ROTC program, individuals who enroll in the ROTC Advanced Course (the second two years of college) must serve in the U.S. Army for three years. Scholarship recipients must serve for four years.

**State Expenditures:** General fund expenditures increase by an estimated \$1.0 million in fiscal 2019 for the scholarship and related administrative costs. Although funding is discretionary in fiscal 2019, this analysis assumes full funding given the bill’s July 1, 2018 effective date. Annually thereafter, general fund expenditures of at least \$1.0 million are mandated. As the bill does not specify otherwise, this estimate assumes that administrative costs can be covered with the mandated appropriation. The estimate reflects one-time programing costs to add the new scholarship to the Maryland College Aid Processing System (MDCAPS) scholarship system; the cost of hiring one half-time administrative specialist to administer the scholarship program, which includes adopting procedures or regulations, prioritizing students with financial need, and ensuring they meet other specified conditions; and scholarship awards.

Future year expenditures reflect a half-time salary with an annual increase and employee turnover and ongoing operating expenses. Due to elimination of the one-time operating costs and MDCAPS programming costs, the amount of residual funding available for scholarship awards increases – to more than \$962,100 in fiscal 2020 – assuming \$1.0 million is provided for *all* program costs each year, including fiscal 2019. If funding is delayed to fiscal 2020, then one-time programming and administrative costs are incurred in that year.
