10. Description and Purpose of Organization (Limit length to visible area)

The mission of the Germantown Historical Society is to educate the community about local history, to provide an archive for local historical information, and to preserve local historic sites. Since its incorporation as a non-profit in 1990 the Society has served the local community by sponsoring two public programs a year, participating in the annual Montgomery County Heritage Days, giving tours and lectures to local groups, publishing a quarterly newsletter, publishing books, videos and pictures of historic sites for schools and public places, applying for historic designations, advocating for historic preservation, and erecting historic markers. Our monthly Community Flea Markets have become a local trademark event as well as a profitable fund raiser. See our website for a list of our past projects: www.germantownMDhistory.org.

11. Description and Purpose of Project (Limit length to visible area)

The Society owns the 1922 Historic Germantown Bank Building in the Germantown Historic District. The interior of the building contains the original walk-in vault, a row of the original safe deposit boxes, and currently has a Handicap accessible restroom and exterior door. The foundation and interior of the building were damaged by water run-off from the County commuter parking lot surrounding the building. This has been a problem for many years while the County owned the property and has created both interior and exterior damage to the building. The estimate for creating a new drainage system around the building and repairing the interior and exterior damage is \$225,000. A museum consultant will be hired for a museum to focus on the History of Banking, and the History of Germantown, to be a teaching tool for all ages to demonstrate how a bank works, how money is invested, loaned and saved; and how the banking institutions of the early 20th century are different.

28. Comments

Since 2013 the Germantown Historical Society has been spending money and volunteer hours to repair and mitigate the water damage to the building caused by run-off from the commuter parking lot surrounding the building. Before we can create a museum of Banking History inside the building we need to stop the water from coming into the building and repair the damage done to the floors, joists, woodwork and plaster walls.

We want to hire a contractor who has worked with old historic buildings before with proven methods and materials. We got three estimates, but Oak Grove Restoration, although the highest, will install a drainage system that has proven to work with other historic buildings, has a national reputation and a very high approval rating. There is no other company in Maryland that can do this work as well. As contractor they will also repair and restore the interior of the building. Their total estimate is: \$24,255 for design, \$118,054 for the exterior, \$81,221 for the interior for a total of \$223,530.

This is a small building, but has great potential for education, community pride, and heritage tourism. Germantown, as an unincorporated city, has very few things to call its own, things that the whole community can identify with. The annual Germantown Oktoberfest is gone. The Spring Festival and fourth of July parades of the past have disappeared. We no longer have a printed newspaper. The Germantown Historic District and the Historic Germantown Bank Building, as evidence of the original agricultural railroad town that the new new has been built around, can give a central focus to this disjointed six-square mile urban area with three zip codes, two separate state election districts, and more than 90,000 people

Our proposal fits very nicely within the County Planning Department's MARC Rail Communities Sector Plan for the future of the area around the railroad station, including and featuring the Historic District and the Germantown Bank Museum, and we have their complete support.

It is vital to the community as well as to our organization that we have the funding to repair the Germantown Bank and create the Museum of Banking History, which will be unique in Maryland, and thus also an asset to the State of Maryland. It will also be an asset to all of the residents of all races, cultures, ethnicity, or background as everyone uses money and banks and would benefit from learning more about their history and how they work.

We hope that you will support our effort to create this asset to the state of Maryland and focal point for the local community.
