AMENDMENT NO. 1

On page 1, in line 3, strike "certain" and substitute "<u>recyclable</u>"; in line 4, strike "<u>zoned for office use</u>" and substitute "<u>that have a certain square footage of office space</u>"; in line 6, strike "<u>buildings zoned for office use</u>" and substitute "<u>office buildings</u>"; in the same line, after "for" insert "<u>the collection and</u>"; in line 7, after the first "<u>certain</u>" insert "<u>recyclable</u>"; in the same line, after "date;" insert "<u>authorizing a certain tenant to carry out certain recycling requirements under certain circumstances</u>."; in lines 8 and 11, in each instance, strike "clarifying" and substitute "<u>specifying</u>"; in line 10, strike ", <u>suspend</u>."; in line 14, strike "<u>building owner or tenant</u>" and substitute "<u>office building owner or tenant of an office building</u>"; in line 15, strike "the recycling required under this Act" and substitute "<u>certain term</u>;"; strike beginning with "clarifying" in line 19 down through "legislation" in line 20 and substitute "<u>providing that this Act may not be construed to preempt or prevail over any ordinance, resolution, law, or rule more stringent than this Act"; in line 21, after "to" insert "<u>the collection and</u>"; and in line 22, strike "<u>for office buildings</u>" and substitute "<u>of recyclable materials from office buildings</u>".</u>

AMENDMENT NO. 2

On page 3, in line 28, strike "<u>ARE</u>" and substitute "<u>HAVE</u>"; and in lines 28 and 29, strike "<u>AND ZONED FOR OFFICE USE</u>" and substitute "<u>OF OFFICE SPACE</u>".

AMENDMENT NO. 3

On page 4, strike in their entirety lines 7 through 10, inclusive, and substitute:

"(A) (1) IN THIS SECTION, "OFFICE BUILDING" MEANS A BUILDING THAT HAS 150,000 SQUARE FEET OR GREATER OF OFFICE SPACE.";

in lines 15, 25, and 28, in each instance, strike "A" and substitute "<u>AN OFFICE</u>"; in line 17, strike "<u>ZONED FOR OFFICE USE</u>"; in line 18, strike "<u>OR SUSPEND</u>,"; in lines 20 and 21, strike "<u>AFFECT A SINGLE PROPERTY</u>" and substitute "<u>ARE IDENTIFIED BY THE</u> <u>OFFICE BUILDING OWNER IN AN APPLICATION TO THE COUNTY OR MUNICIPALITY</u> <u>FOR AN ALTERATION OR EXEMPTION</u>"; in line 27, strike "ON" and substitute "<u>SUBJECT TO PARAGRAPH (2) OF THIS SUBSECTION, ON</u>"; in lines 27 and 28, strike "<u>UNLESS OTHERWISE AGREED BETWEEN AN OWNER AND A TENANT</u>,"; strike beginning with "<u>THAT</u>" in line 30 down through "<u>USE</u>" in line 31; and in lines 32 and 33, strike "<u>A RECYCLING RECEPTACLE ON THE PROPERTY</u>" and substitute "<u>RECYCLING RECEPTACLES</u>".

On page 5, in line 2, after "MATERIALS" insert "<u>, AS DETERMINED BY THE</u> <u>COUNTY OR MUNICIPALITY IN WHICH THE BUILDING IS LOCATED</u>,"; in line 3, strike "RECEPTACLE" and substitute "<u>RECEPTACLES</u>"; in line 5, strike "<u>ALUMINUM, STEEL</u>, <u>AND TIN CANS</u>" and substitute "<u>METAL</u>"; in line 6, strike "<u>BOTTLES</u>" and substitute "<u>MATERIALS</u>"; strike beginning with "<u>AND</u>" in line 6 down through "<u>LOCATED</u>" in line 7; after line 7, insert:

"(2) ON AGREEMENT BETWEEN AN OFFICE BUILDING OWNER AND THE TENANT OF THE OFFICE BUILDING, A TENANT MAY CARRY OUT THE RECYCLING REQUIRED UNDER THIS SUBSECTION.";

in line 8, strike "(2)" and substitute "(3)"; in the same line, strike "A" and substitute "<u>AN OFFICE</u>"; in line 9, strike the second "<u>A</u>" and substitute "<u>AN OFFICE</u>"; in line 10, strike "PARAGRAPH (1) OF"; and in line 16, strike "<u>BUILDING</u>" and substitute "<u>OFFICE</u> <u>BUILDING</u>".
