AMENDMENTS TO HOUSE BILL 195

(First Reading File Bill)

AMENDMENT NO. 1

On page 1, strike beginning with "Curriculum" in line 2 down through "Requirement" in line 3 and substitute "Pilot Program Course"; strike beginning with "requiring" in line 5 down through the period in line 12 and substitute "requiring the Prince George's County Board of Education to develop and implement a certain pilot program that includes an elective course on financial literacy as a part of the county board's high school curriculum; requiring the county board to develop the curriculum content for a certain course in financial literacy as a part of the pilot program; requiring the county board to select a certain number of high schools in the county to participate in the pilot program; requiring the county board to submit a certain report to the Prince George's County Senate and House Delegations on or before a certain date each year; providing for a delayed effective date; providing for the termination of this Act; and generally relating to a pilot program course in financial literacy in Prince George's County."; strike line 13 in its entirety and substitute "BY adding to"; and in line 15, strike "3–1008" and substitute "3–1008.1".

AMENDMENT NO. 2

On pages 1 and 2, strike in their entirety the lines beginning with line 21 on page 1 through line 22 on page 2, inclusive, and substitute:

"<u>3–1008.1.</u>

(A) BEGINNING IN THE 2020–2021 SCHOOL YEAR, THE COUNTY BOARD SHALL DEVELOP AND IMPLEMENT A PILOT PROGRAM THAT INCLUDES A SEMESTER-LONG ELECTIVE COURSE IN FINANCIAL LITERACY AS A PART OF THE COUNTY BOARD'S HIGH SCHOOL CURRICULUM.

- (B) THE COUNTY BOARD SHALL DEVELOP CURRICULUM CONTENT FOR THE COURSE IN FINANCIAL LITERACY.
- (C) THE COUNTY BOARD SHALL SELECT AT LEAST ONE HIGH SCHOOL IN THE COUNTY TO PARTICIPATE IN THE PILOT PROGRAM.

SECTION 2. AND BE IT FURTHER ENACTED, That, on or before June 30 each year, the Prince George's County Board of Education shall submit a report, in accordance with § 2–1246 of the State Government Article, to the Prince George's County Senate and House Delegations on the success of the pilot program developed and implemented under this Act.

SECTION 3. AND BE IT FURTHER ENACTED, that this Act shall take effect July 1, 2020. It shall remain effective for a period of 3 years and, at the end of June 30, 2023, this Act, with no further action required by the General Assembly, shall be abrogated and of no further force and effect."
