## AMENDMENT NO. 1

On page 1, in line 5, strike "receiving" and substitute "<u>managing</u>"; in line 6, after the semicolon insert "<u>requiring the Department to select a certain managing</u> <u>organization</u>;"; in the same line, after "Department" insert "<u>and managing</u> <u>organization</u>"; in line 7, strike "place them in receiving organizations working in certain areas" and substitute "<u>support them in their matriculation in certain fields of study at</u> <u>an institution of higher education</u>"; in the same line, after the semicolon insert "<u>authorizing the Department or managing organization to require a fellow to complete</u> <u>certain tasks</u>;"; in line 8, strike "in addition to a certain salary"; and in the same line, after the semicolon insert "<u>providing for the use of certain funds</u>;".

#### AMENDMENT NO. 2

On page 5, in line 28, strike "**RECEIVING**" and substitute "<u>MANAGING</u>"; and in lines 28 and 29, strike "WHERE A FELLOW IS PLACED" and substitute "<u>SELECTED BY</u> <u>THE DEPARTMENT TO COORDINATE THE ADMINISTRATION OF THE FELLOWSHIP</u> <u>PROGRAM WITH THE DEPARTMENT</u>".

On page 6, strike beginning with the second "THE" in line 1 down through "MANAGEMENT" in line 3 and substitute "<u>STUDENTS SEEKING A CAREER IN FIELDS</u> <u>RELATING TO NATURAL RESOURCES AS THEY MATRICULATE AND GRADUATE</u> <u>FROM AN INSTITUTION OF HIGHER EDUCATION</u>"; in line 6, strike "**RECEIVING**" and substitute "<u>MANAGING</u>"; after line 6, insert:

# "(E) THE DEPARTMENT SHALL SELECT A MANAGING ORGANIZATION WITH WHICH THE DEPARTMENT SHALL COORDINATE TO ADMINISTER THE FELLOWSHIP PROGRAM UNDER THIS SECTION.";

in line 7, strike "(E)" and substitute "(F)"; in line 8, after "DEPARTMENT" insert "AND THE MANAGING ORGANIZATION"; in lines 8 and 9, strike "PLACE THEM IN RECEIVING ORGANIZATIONS" and substitute "SUPPORT THEM IN THEIR MATRICULATION IN A NATURAL RESOURCES FIELD AT AN INSTITUTION OF HIGHER EDUCATION"; in lines 10 and 11, strike "PLACED AT A RECEIVING ORGANIZATION WORKING IN THE AREA OF FORESTRY MANAGEMENT" and substitute "SEEKING A DEGREE TO WORK IN THE FIELD OF NATURAL RESOURCES MANAGEMENT"; in lines 12 and 13, strike "PLACED AT A RECEIVING ORGANIZATION WORKING IN THE AREA OF" and substitute "SEEKING A DEGREE TO WORK IN THE FIELD OF"; after line 13, insert:

# "(G) <u>The Department or the managing organization may require</u> <u>A FELLOW TO COMPLETE TASKS RELATED TO THE FELLOWSHIP PROGRAM IN</u> <u>ADDITION TO THE FELLOW'S COURSE OF STUDY.</u>";

in line 14, strike "(F)" and substitute "(H)"; in lines 14 and 15, strike "IN ADDITION TO ANY SALARY PROVIDED BY THE RECEIVING ORGANIZATION, A" and substitute "(1) <u>A</u>"; and after line 16, insert:

"(2) ANY FUNDS REMAINING AFTER THE STIPENDS UNDER PARAGRAPH (1) OF THIS SUBSECTION ARE DISTRIBUTED FROM THE GOVERNOR'S APPROPRIATION REQUIRED UNDER § 5–307 OF THIS SUBTITLE SHALL BE USED FOR THE ADMINISTRATION OF THE FELLOWSHIP PROGRAM, INCLUDING THE RECRUITMENT, SELECTION, AND SUPERVISION OF THE FELLOWS BY THE DEPARTMENT AND THE MANAGING ORGANIZATION.".
