AMENDMENT NO. 1

On page 1, in line 3, after the first "of" insert "<u>requiring the State Superintendent</u> of Schools to provide a county superintendent of schools with certain information if the <u>State Superintendent intends to remove the county superintendent</u>;"; strike beginning with "file" in line 3 down through the second "of" in line 4 and substitute "<u>remove</u>"; in line 5, strike "of schools" and substitute "<u>in a certain manner</u>"; strike beginning with "specifying" in line 5 down through "circumstances;" in line 11; and strike beginning with "authorizing" in line 15 down through "Education;" in line 17.

AMENDMENT NO. 2

On page 2, in line 31, after "Superintendent" insert "OR A COUNTY BOARD".

On page 3, strike in their entirety lines 5 through 20, inclusive; in lines 21, 28, and 29, in each instance, strike the brackets; strike beginning with "(3)" in line 21 down through the period in line 27 and substitute "<u>THE STATE SUPERINTENDENT MAY</u> <u>REMOVE A COUNTY SUPERINTENDENT UNDER THIS SUBSECTION IF THE STATE</u> <u>SUPERINTENDENT PROVIDES THE COUNTY SUPERINTENDENT WITH:</u>

(I) <u>THE REASON FOR REMOVAL, CHOSEN FROM ONE OR</u> MORE OF THE ITEMS IN PARAGRAPH (1) OF THIS SUBSECTION;

(II) DOCUMENTATION SUPPORTING THE CASE FOR REMOVAL; AND

(III) <u>THE OPPORTUNITY TO REQUEST A HEARING WITHIN 10</u> DAYS BEFORE THE STATE SUPERINTENDENT IN ACCORDANCE WITH THIS SUBSECTION.";

in line 28, strike "(4)"; and in line 29, strike "30-DAY".

On page 4, in line 1, strike the bracket; strike beginning with the bracket in line 2 down through "**11**" in line 3; strike beginning with the semicolon in line 4 down through "**BOARD**" in line 7; after line 10, insert:

"(4) <u>A COUNTY BOARD MAY REMOVE A COUNTY SUPERINTENDENT</u> <u>UNDER THIS SUBSECTION IF THE COUNTY BOARD PROVIDES THE COUNTY</u> <u>SUPERINTENDENT WITH:</u>

(I) <u>THE REASON FOR REMOVAL, CHOSEN FROM ONE OR</u> MORE OF THE ITEMS IN PARAGRAPH (1) OF THIS SUBSECTION;

(II) DOCUMENTATION SUPPORTING THE CASE FOR REMOVAL; AND

(III) <u>THE OPPORTUNITY TO REQUEST A HEARING WITHIN 10</u> DAYS BEFORE AN ARBITRATOR IN ACCORDANCE WITH THIS SUBSECTION.";

in line 12, strike "**30–DAY**" and substitute "<u>**10–DAY**</u>"; and in lines 16, 19, and 30, in each instance, strike "**STATE SUPERINTENDENT**" and substitute "<u>**COUNTY BOARD**</u>".

On page 5, in lines 4, 8 and 9, and 13 and 14, in each instance, strike "STATE SUPERINTENDENT" and substitute "<u>COUNTY BOARD</u>"; in line 15, strike "STATE" and substitute "<u>COUNTY BOARD</u>"; in line 20, strike "AN INDIVIDUAL" and substitute "<u>A</u><u>PARTY</u>"; and strike in their entirety lines 23 through 26, inclusive.
