## AMENDMENT NO. 1

On page 1, in the sponsor line, strike "Delegate Washington" and substitute "Delegates Washington, Walker, Smith, Guyton, Cain, Wilkins, Ebersole, Mosby, Turner, Ivey, Palakovich Carr, and Feldmark".

## AMENDMENT NO. 2

On page 2, strike beginning with "ONE" in line 5 down through "(3)" in line 9; strike beginning with "(4)" in line 11 down through "(5)" in line 13 and substitute "(2)"; strike beginning with "(6)" in line 15 down through "(9)" in line 22 and substitute "(3)"; and in line 25, strike "(10)" and substitute "(4)".

On pages 2 and 3, strike in their entirety the lines beginning with line 27 on page 2 through line 19 on page 3, inclusive, and substitute:

- "(5) ONE REPRESENTATIVE OF THE MARYLAND ASSOCIATION OF BOARDS OF EDUCATION, SELECTED BY THE PRESIDENT OF THE MARYLAND ASSOCIATION OF BOARDS OF EDUCATION;

- (7) ONE REPRESENTATIVE OF THE PUBLIC SCHOOLS SUPERINTENDENTS ASSOCIATION OF MARYLAND, SELECTED BY THE EXECUTIVE DIRECTOR OF THE PUBLIC SCHOOL SUPERINTENDENTS ASSOCIATION OF MARYLAND;

- (8) ONE REPRESENTATIVE OF THE MARYLAND ASSOCIATION OF STUDENT COUNCILS, SELECTED BY THE PRESIDENT OF THE MARYLAND ASSOCIATION OF STUDENT COUNCILS;
- (9) ONE REPRESENTATIVE OF THE MARYLAND OFFICE OF THE PUBLIC DEFENDER, SELECTED BY THE MARYLAND PUBLIC DEFENDER;
- (10) ONE REPRESENTATIVE OF COMMUNITY MEDIATION MARYLAND, SELECTED BY THE EXECUTIVE DIRECTOR OF COMMUNITY MEDIATION MARYLAND;
- (11) ONE PARENT OF A STUDENT WITH DISABILITIES, SELECTED BY THE EXECUTIVE DIRECTOR OF THE ARC MARYLAND; AND

On page 3, in line 20, strike "(20)"; in line 21, strike "PTA;" and substitute "PTA."; and strike in their entirety lines 22 through 27, inclusive.

On page 4, in lines 1 and 4, in each instance, strike "CENTER FOR DISPUTE RESOLUTION" and substitute "MARYLAND EQUITY PROJECT"; and in lines 2 and 5, in each instance, strike "SCHOOL OF LAW" and substitute "COLLEGE OF EDUCATION".
