(III) IF THE LICENSE HOLDER IS ALSO THE HOLDER OF A CLASS 5 BREWERY LICENSE, THE SALE OF ONLY BEER IN ACCORDANCE WITH § 2207 OF THIS ARTICLE ON THE PREMISES OF THE CONCESSIONAIRE FOR CONSUMPTION ON:

1. THE LICENSED PREMISES OF THE CONCESSIONAIRE; AND

(2) A HOLDER OF THE LICENSE NEED NOT OBTAIN A SUNDAY LICENSE UNDER $\S 11-2004$ OF THIS TITLE TO SELL ALCOHOLIC BEVERAGES AFTER 2 A.M. ON SUNDAY.

On page 4, in line 13, after "The" insert "ANNUAL"; and in the same line, strike " $\$ 60$ per day of live or simulcast racing" and substitute " $\mathbf{\$ 2 5 , 0 0 0}$ ".
