13 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
 14 That Section(s) 16–402(a)(16) through (42), respectively, of Article – Transportation of the
 15 Annotated Code of Maryland be renumbered to be Section(s) 16–402(a)(17) through (43),
 16 respectively.

17 SECTION 2. AND BE IT FURTHER ENACTED, That the Laws of Maryland read
 18 as follows:

19 **Article – Transportation**

20 16–301.

21 (h) A person may not possess any canceled license.

22 (i) A person may not possess any revoked license.

23 (j) A person may not possess any suspended license.

24 (r) (1) Except as provided in [paragraph] **PARAGRAPHS (2) AND (3)** of this
 25 subsection, a person convicted of a violation of this section is subject to imprisonment not
 26 exceeding 2 months or a fine not exceeding \$500 or both.

27 (2) A person convicted of a violation of subsection (a) or (b) of this section
 28 is subject to imprisonment not exceeding 3 years or a fine not exceeding \$2,500 or both.

29 **(3) A PERSON CONVICTED OF A VIOLATION OF SUBSECTION (H), (I),**
 30 **OR (J) OF THIS SECTION IS SUBJECT TO A FINE NOT EXCEEDING \$500.**

32 (a) After the conviction of an individual for a violation of Title 2, Subtitle 5, §
 33 2–209, § 3–211, or § 10–110 of the Criminal Law Article, or of the vehicle laws or regulations

1 of this State or of any local authority, points shall be assessed against the individual as of
2 the date of violation and as follows:

3 **(16) A VIOLATION OF § 16-301(H), (I), OR (J) OF THIS TITLE....3 POINTS**

4 (36) Any violation of [§ 16-301] **§ 16-301(A) THROUGH (G) OR (K)**
5 **THROUGH (Q)**, § 16-302, § 16-804, or § 16-808(a)(1) through (9) or (b) of this
6 title.....12 points

7 SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect
8 October 1, 2019.
