7	(ii) "Advertisement" includes any correspondence, mailing,			
8	newsletter, brochure, business card, for sale or for lease sign and sign rider, promotional			
9	item, automobile signage, telephone directory listing, television announcement, radio			
10	announcement, telephone solicitation, and World Wide Web and Internet voice-overs.			
11	(4) (i) "Designated name" means the individual name of a licensed real			
12	estate salesperson, licensed real estate broker, or licensed associate real estate broker other			
13	than the licensed real estate salesperson's, licensed real estate broker's, or licensed			
14	associate real estate broker's full legal name.			
15	(ii) "Designated name" includes a first name, nickname, or last			
16	name.			
17	(b) A licensed real estate salesperson, licensed real estate broker, or licensed			
18	associate real estate broker may not advertise unless:			
19	(1) the name or designated name of the licensed real estate salesperson,			
20	licensed real estate broker, or licensed associate real estate broker, as the name or			
21	designated name appears on the license certificate and pocket card issued by the			
22	Commission, is meaningfully and conspicuously included in the advertisement; and			
23	(2) the name of the business with which the licensed real estate			
24	salesperson, licensed real estate broker, or licensed associate real estate broker is affiliated:			
25	(i) is meaningfully and conspicuously included in the			
26	advertisement; and			
27	(ii) is the full name of the business and not a logo used by the			
28	business.
