## A BILL ENTITLED

2 **Prince George's County Board of Education – Members' Expense Forms –**  
3 **Publication on Website**

5 FOR the purpose of requiring the Prince George's County public school system to publish  
6 prominently on its website links to certain expense forms filed by members of the  
7 Prince George's County Board of Education; requiring certain expense forms filed by  
8 members of the Prince George's County Board of Education to be designated as  
9 certain public records available to any applicant immediately on request and  
10 included on a certain list posted on the school system's website; and generally  
11 relating to the members of the Prince George's County Board of Education.

22 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,

23 That the Laws of Maryland read as follows:

2 (A) THE PRINCE GEORGE'S COUNTY PUBLIC SCHOOL SYSTEM SHALL  
3 PUBLISH PROMINENTLY ON ITS WEBSITE A LINK TO EACH EXPENSE FORM FILED BY  
4 A MEMBER OF THE COUNTY BOARD FOR REIMBURSEMENT BY THE SCHOOL SYSTEM.

5 (B) EACH EXPENSE FORM FILED BY A MEMBER OF THE COUNTY BOARD FOR  
6 REIMBURSEMENT BY THE PRINCE GEORGE'S COUNTY PUBLIC SCHOOL SYSTEM  
7 SHALL BE:

8 (1) DESIGNATED AS A PUBLIC RECORD AVAILABLE TO ANY  
9 APPLICANT IMMEDIATELY ON REQUEST UNDER § 4-201(C)(1) OF THE GENERAL  
10 PROVISIONS ARTICLE; AND

11 (2) LISTED ON THE CURRENT LIST OF TYPES OF PUBLIC RECORDS  
12 DESIGNATED AS AVAILABLE TO ANY APPLICANT IMMEDIATELY ON REQUEST UNDER  
13 § 4-201(C)(2) OF THE GENERAL PROVISIONS ARTICLE THAT IS POSTED ON THE  
14 WEBSITE OF THE PRINCE GEORGE'S COUNTY PUBLIC SCHOOL SYSTEM.

15 Article – General Provisions

16 4-201.

17 (c) Each official custodian shall:

18 (1) designate types of public records of the governmental unit that are to  
19 be made available to any applicant immediately on request; and

20 (2) maintain a current list of the types of public records that have been  
21 designated as available to any applicant immediately on request.

22 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect  
23 October 1, 2019.
