- 3 (B) (1) THE ADMINISTRATION SHALL PROVIDE RIDERSHIP ON TRANSIT 4 VEHICLES TO ANY ELIGIBLE STATE EMPLOYEE.
- 5 (2) THE SERVICES PROVIDED UNDER PARAGRAPH (1) OF THIS 6 SUBSECTION APPLY TO TRANSIT VEHICLES THAT ARE PART OF THE 7 ADMINISTRATION'S:

- 24 employee transit ridership program to:
- 25 (1) include ridership on the Maryland Area Regional Commuter (MARC)
- 26 Train Service and the Washington Metropolitan Area Transit Authority (WMATA); and
- 27 (2) employees of the Legislative and Judicial Branches of State 28 government.
- SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect July 30 $\,$ 1, 2019.
