A BILL ENTITLED

1 AN ACT concerning

2 **Cownose Ray Fishery Management Plan and Moratorium on Contests**

3 FOR the purpose of extending the date by which the Department of Natural Resources is
4 required to prepare a certain fishery management plan for the cownose ray species,
5 subject to available funding; extending the termination date for the prohibition on a
6 person sponsoring, conducting, or participating in a certain cownose ray fishing
7 contest in State waters; and generally relating to the cownose ray fishery.

19 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
20 That the Laws of Maryland read as follows:

21 **Article – Natural Resources**

5 SECTION 2. AND BE IT FURTHER ENACTED, That, on or before December 31,
6 [2018] 2020, subject to funding made available to the Department of Natural Resources to
7 implement Section 1 of this Act, the Department shall prepare the cownose ray fishery
8 management plan required by § 4–215(b)(25) of the Natural Resources Article, as enacted
9 by Section 1 of this Act.

10 SECTION 3. AND BE IT FURTHER ENACTED, That:

11 (a) In this section, “cownose ray fishing contest” means any competition,
12 tournament or derby with the objective of catching or killing cownose rays for:

13 (1) prizes or other inducements; or

14 (2) entertainment purposes.

15 (b) Until July 1, [2019] 2021, a person may not sponsor, conduct, or participate
16 in a cownose ray fishing contest in State waters.

17 (c) A person who violates subsection (b) of this section is guilty of a misdemeanor,
18 and on conviction is subject to the penalties provided in § 4–1201(a) and (b) of the Natural
19 Resources Article.

21 SECTION 2. AND BE IT FURTHER ENACTED, That on or before December 31,
22 [2018] 2020, subject to funding made available to the Department of Natural Resources to
23 implement Section 1 of this Act, the Department shall prepare the cownose ray fishery
24 management plan required by § 4–215(b)(25) of the Natural Resources Article, as enacted
25 by Section 1 of this Act.

26 SECTION 3. AND BE IT FURTHER ENACTED, That:

27 (a) In this section, “cownose ray fishing contest” means any competition,
28 tournament, or derby with the objective of catching or killing cownose rays for:

29 (1) prizes or other inducements; or

30 (2) entertainment purposes.

1 (b) Until July 1, [2019] **2021**, a person may not sponsor, conduct, or participate
2 in a cownose ray fishing contest in State waters.

3 (c) A person who violates subsection (b) of this section is guilty of a misdemeanor,
4 and on conviction is subject to the penalties provided in § 4–1201(a) and (b) of the Natural

7 1, 2019.
